SUBJECT: Administrative Review Status Report

Title 20, Chapter 20 (Historic Landmark Preservation), El Paso Municipal Code, allows this Department to provide Administrative Review for applications that meet criteria as listed under the Administrative Review Guidelines. Since the Historic Landmark Commission meeting on April 18, the following cases have been given Administrative Review:

AUSTIN TERRACE HISTORIC DISTRICT

PHHR16-00077-1404 Raynolds Street, Ramon Chavez (owner) – Non-Contributing Property - A request was made to install new silver-colored fiberglass roof on garage. Current roof has no shingles. Additionally, replacing one 1x2 wood plannel that goes under roof, new board will match existing.

PHHR16-00079-4431 Trowbridge Drive, David and Teresa Ochoa (owner) – Contributing Property - A request was made for the removal and replacement of rooftop a/c unit. New unit to be located in same area as old unit on the roof of the rear addition.

PHHR16-00085-1801 Raynolds Street, Alice Villareal (owner) – Non-Contributing Property - A request was made for re-roofing w/Owens-Corning asphalt shingles in "Shasta White" to match existing.

PHHR16-00087-4810 Chesterfield Avenue, Maureen and Robert Lofberg (owners) – Non-Contributing Property - A request was made for the removal of existing rooftop a/c unit and replacement with new unit in same location on rear of roof.
