SUBJECT: Administrative Review Status Report

Title 20, Chapter 20 (Historic Landmark Preservation), El Paso Municipal Code, allows this Department to provide Administrative Review for applications that meet criteria as listed under the Administrative Review Guidelines. Since the Historic Landmark Commission meeting on August 18, 2014 the following cases have been given Administrative Review:

AUSTIN TERRACE

PHHR14-00105–1516 Reynolds Street, The Rotz Family Trust (owner) –Non-Contributing Property - A request was made to replace the broken gas line from meter to home in rear yard only. No work on facades.

PHHR14-00106–24 Cumberland Circle, Roberta and Patrick Bramblett (owners) –Contributing Property - A request was made to re-roof w/Boral Roofing concrete roof tiles in a mix of "Barro Rojo" and "Verona Clay" to match the existing roof.

PHHR14-00109–4327 Oxford Avenue, Oscar and Maria Lozano (owners) –Contributing Property - A request was made to replace the gas line to include trenching in rear yard. No alterations to the buildings or fences on the property.
