

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.200 (SCHEDULE XVII--RESTRICTIONS ON PARKING IN RESIDENTIAL DISTRICTS), OF THE EL PASO CITY CODE, TO AMEND ZONE C, NO PARKING 8:00 A.M.-2:00 P.M., MONDAY THROUGH FRIDAY SCHOOL DAYS ONLY, TOW-AWAY ZONE. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

The residents in the area are suffering undo congestion and parking problems due to the influx of students from the University of Texas at El Paso. The residents have requested parking be restricted to only those that live on this street. The Engineering Traffic Division recommends this ordinance.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.200 (SCHEDULE XVII--RESTRICTIONS ON PARKING IN RESIDENTIAL DISTRICTS), OF THE EL PASO CITY CODE, TO AMEND ZONE C, NO PARKING 8:00 A.M.-2:00 P.M., MONDAY THROUGH FRIDAY SCHOOL DAYS ONLY, TOW-AWAY ZONE. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVII, Restrictions on parking in residential districts), Zone C, of the El Paso City Code shall be and hereby is amended to read as follows:

ZONE C: No parking 8:00 a.m. – 2:00 p.m., Monday through Friday School Days Only, Tow-Away Zone

- Beginning at the intersection of the west right-of-way line of North Oregon Street and Boston Avenue;
- Thence east along the north right-of-way line of Boston Avenue to its intersection with the east right-of-way line of Campbell Street;
- Then south along the east right-of-way line of Campbell Street to its intersection with the north right-of-way line of New York Avenue;
- Thence east along the north right-of-way line of New York Avenue to its intersection with the east right-of way line of Rim Road;
- Thence, southwest along the east right-of-way line of Rim Road to its intersection with the east right-of-way line of North Oregon Street;
- Thence north along the east right-of-way line of Oregon Street to the point of beginning.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVII, Restrictions on parking in residential districts), of the El Paso City Code shall remain in full force and effect.
