Discussion and action on the award of Solicitation No. 2008-073 for the Construction of Storm 2006: Upper Valley Drainage Improvements Phase I to C.F. Jordan, L.P., El Paso, Texas for an estimated total amount of \$ 10,427,250.00

It is requested that the City Manager of the City of El Paso be authorized to sign any contracts or other documents required to effectuate this award and be authorized to exercise on behalf of the City any extensions of the contract.

Work under this unit price contract is only an estimated value and will be ordered, performed, invoiced, and paid by measured quantity. The actual cost of this contract will be the sum total of unit prices at the end of the contract term.

As part of the award of this contract, the City Engineering Department may, without further authorization from City Council, approve contract changes which are necessary for proper construction of the work and carrying out the intent of the design, which are in accordance with applicable law, and which do not make changes to the unit price and which are within the appropriate budget.

This is a low bid, unit-price contract. The Financial Services and Engineering Departments recommend award as indicated to the lowest responsive, responsible bidder.

BACKGROUND / DISCUSSION:

Drainage improvement projects have been the main thrust of the City's Engineering Department since the unfortunate events of the flooding storms of the year 2006. This project will help alleviate much flooding to this part of the city located within district No. 1 in the Upper Valley. This drainage project was critically needed, constant flooding has been a problem endured by the residents of this area for a very long time. The Upper Valley Drainage Improvements Phase I Project will bring much needed drainage infrastructure improvements to these neighborhoods, area residents will enjoy more pleasant living conditions, an added sense of security and higher quality of life when construction of this project is finished. The solicitation for bids for this project is based on a Unit-Price contract that is awarded on the basis of the lowest total amount bid for all the items in the solicitation proposal. C.F. Jordan, L.P. submitted the lowest responsive and responsible bid. The purpose of this agenda item is to award this project to C.F. Jordan, L.P. the lowest responsive and responsible bidder. The approximate total value of this project is estimated to be \$10,427,250.00. C.F. Jordan was the sole contractor submitting a bid for this solicitation.





Scope of Work

Storm 2006: Upper Valley Drainage Improvements Solicitation No. 2008-073

BASE BID I: (Unit Price Schedule)

McCutcheon Basin Modifications:

The work, defined in Section 01010 SUMMARY OF WORK of the project specifications, covers all items of construction required for the modification of the McCutcheon Basin as shown on the Drawings. This shall include layout, excavation, import of soil from barrow source, subgrade preparation, construction of foundation and berms to elevations and grades shown on the plans and specification requirements. Work shall include placement of loose rock rip rap on exterior of the berms as shown on drawings. Basin shall have 6-inch base course road around the perimeter of basin with sections overlaid with 2-inch HMA as shown in the plans. Basin will include an 8-inch thick concrete overflow spillway. Other improvements include: removing and replacing the existing concrete flumes as shown in plans; storm sewer pipes; inlets; manholes; outlet structures; and, chain link fence at perimeter of basin. The construction shall include: implementation and maintenance of a storm water pollution prevention plan; dewatering as required; and, all other incidental and subsidiary items necessary to construct a completed facility.

BASE BID II: (Unit Price Schedule)

McCutcheon Pump Station:

The work, defined in Section 01010 SUMMARY OF WORK of the project specifications, covers all items required for the construction of the new McCutcheon Basin Pump Station. The construction shall include: the Basin Pump Station, Basin Draw Down Pump Station, and Electrical Building, including: site electrical service, SCADA control, automatic traveling trash rake with screens, stand-by generator equipment, HVAC equipment, and site piping as shown on the drawings. The construction shall include: implementation and maintenance of a storm water pollution prevention plan; dewatering as required; and, all other incidental and subsidiary items necessary to construct a completed facility.

BASE BID III:

(Unit Price Schedule)

McCutcheon Draw Down Piping:

The work, defined in Section 01010 SUMMARY OF WORK of the project specifications, includes items in the installation of 12-inch force main piping from the Draw Down Pump Station to the existing culvert located east of Doniphan as shown on the Drawings. The construction of: a discharge structure at Doniphan; HMAC removal and replacement; implementation of a traffic control plan; implementation and maintenance of a storm water pollution prevention plan; dewatering as required; and, subsidiary items necessary to install the proposed draw basin down force main.

BASE BID IV:

(Unit Price Schedule)

Joe Santos Basin Expansion:

The work, defined in Section 01010 SUMMARY OF WORK of the project specifications, covers all items required in the modifications of the Joe Santos Basin. This includes, but is not limited to: layout, excavation, import of soil from barrow source, subgrade preparation, and construction of berms to elevations and grades shown on the plans and specification requirements. Basin shall have 6-inch base course road around perimeter of basin as shown in plans and an 8-inch thick concrete overflow spillway. Other improvements include: removing and replacing existing concrete flumes as shown in plans; storm sewer pipes; inlets; manholes; outlet structures; chain link fence at perimeter of basin; implementation and maintenance of a storm water pollution prevention plan; and, all other incidental and subsidiary items necessary to construct a completed facility.

Notes :

Prior to commencement of any work contractor shall submit and obtain approval from El Paso Engineering Department for the Sequence of Construction, Schedule of Work and Haul/Waste Route to an approved disposal site. Contractor shall provide written approved documentation from the owner or operator of the waste site.

Contractor shall coordinate with the City of El Paso on agreements for work within private property. Contractor shall abide by the agreements established for the project regarding work outside of City of El Paso property.

Implement and maintain the Storm Water Pollution Prevention Plan as required by law **if applicable to this project**

All construction installation and practices shall meet and/or exceed City of El Paso Engineering Standards and other applicable state and federal codes and regulations.

The description of this Scope of Work as shown, is only a general overview of this project. Contractor shall refer to the project plans, specifications and Engineering Department officials for further information.

The undersigned Bidder agrees to commence work on a date to be specified in a written Notice to Proceed and to substantially complete the work on which he/she has bid within **Two Hundred Sixty (260) Consecutive Work Days**. Bidder agrees to pay as liquidated damages the sum of **Two Thousand Two Hundred Dollars (\$2,200.00)** for each consecutive work day thereafter as provided in paragraph 6.8 of the General Conditions of the Contract.
