

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC) CHAPTER 12.88 (SCHEDULES), SECTION 12.88.210 (SCHEDULE XVIII – RESTRICTIONS ON COMMERCIAL VEHICLE PARKING ON RESIDENTIAL STREETS) TO DELETE SAN ANTONIO AVENUE AND OCHOA STREET, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.210 (Schedule XVIII – Restrictions on commercial vehicle parking on residential streets), of the El Paso City Code, is amended to delete the following paragraphs:

**12.88.210 – Schedule XVIII – Restrictions on commercial vehicle parking on residential streets.**

1. North side of San Antonio Avenue from Florence Street to Ochoa Street;
2. East side of Ochoa Street from San Antonio Avenue to Overland Avenue.

**Section 2.** Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.
