Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking Prohibited at All Times on Certain Streets) to add Roseway Drive and Barker Road, the penalty being as provided in section 12.84.010 and Chapter 12.85 of the El Paso City Code.

BACKGROUND/DISCUSSION:

This ordinance is to restrict parking along Barker Road from J.C. Cramer to a point 1,070 feet north and on Roseway Drive from Presa Place to Carnes Road. Both of these streets are scheduled for reconstruction and the new cross section for both streets will be 20 feet, which isn't wide enough to accommodate parking.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO ADD ROSEWAY DRIVE AND BARKER ROAD, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets), of the El Paso City Code, is amended to add the following paragraphs:

12.88.030 – Schedule III – Parking prohibited at all times on certain streets.

- Roseway Drive from Presa Place to Carnes Road, both sides.
- Barker Road from J.C. Cramer Lane to a point 1,070 feet north, both sides.

Section 2. Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.


