AN ORDINANCE AUTHORIZING THE CITY OF EL PASO TO SELL A PORTION OF LOTS 10, 11, 16, 17, 34 AND 35, BLOCK 12, SUNSET HEIGHTS, SECOND REVISED MAP, EL PASO, EL PASO COUNTY, TEXAS TO DON LUCIANO.

WHEREAS, the City of El Paso staff has recommended the sale of a portion of Lots 10, 11, 16, 17, 34, and 35, Block 12, Sunset Heights, Second Revised Map, El Paso, El Paso County, Texas; and

WHEREAS, the City of El Paso has received an independent appraisal as the market value of its interest in the identified property; and

WHEREAS, in accordance with Section 272.001 of the Texas Local Government Code, the City of El Paso advertised and solicited bids for the purchase of the identified property; and

WHEREAS, Don Luciano is the highest bidder and submitted a bid of \$20,810.00, (which includes an appraisal fee of \$1,450.00 and survey costs of \$5,100.00).

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

That the City Manager be authorized to sign a Contract of Sale and all other necessary documents, in a form approved by the City Attorney's Office, conveying the following parcels to Don Luciano.

Parcel No. 1—a 0.062 acre parcel, more of less, being a portion of Lots 34 and 35, Block 12, Sunset Heights, Second Revised Map, El Paso, El Paso County, Texas, being more particularly described in Exhibit "A" attached hereto and made a part hereof for all purposes; and

Parcel No. 2—a 0.051 acre parcel, more of less, being a portion of Lots 16 and 17, Block 12, Sunset Heights, Second Revised Map, El Paso, El Paso County, Texas, being more particularly described in Exhibit "B" attached hereto and made a part hereof for all purposes; and

1.2 **Surveys.** The Buyer accepts responsibility for conducting its own archeological and environmental surveys of the Property. Any mitigation of any conditions on the Property, including archeological sites or, without limitations, adverse environmental conditions, shall be at the expense of the Buyer who shall take the Property subject to all existing conditions. The Buyer accepts responsibility for their determination of the nature and extent of any archeological sites, or without limitations, any adverse environmental conditions by their complete inspection of the Property.

Otherwise, this condition will be deemed acceptable and any objection by the Buyer will be deemed waived.

4. **Representations of City.** The City hereby represents, to the extent allowed by law, to the Buyer that to the best of its knowledge, as follows:
