SUBJECT:

An ordinance providing for a one hundred per cent reduction of certain fees specified in Title 18, Title 19, and Title 20 of the El Paso City Code for a period of ten years for property development located in the Downtown 2015 Plan Area. Applicant: City of El Paso, Planning and Economic Development, (All Districts).

BACKGROUND / DISCUSSION:

In 2008, the El Paso City Council approved a tiered reduction of various development fees to encourage investment in the renovation, restoration, and rehabilitation of properties and new development and construction within the Tax Increment Zone No. 5 and within neighborhood empowerment zones. The City Council found that the reductions constituted a benefit to the city and encouraged private investment within the applicable areas with a minimal financial impact. The first year provided for a one hundred percent reduction in development fees and decreased by twenty percent every year thereafter terminating in May 2012. This revised ordinance would provide for a one hundred percent reduction in certain development fees as shown in the attached Exhibit "A" within the Downtown Plan area as shown in Exhibit "B". The effect has been calculated for an average of \$143,935.00 per year for the past three years for a total of \$431,804.00 in development fees since 2009.

PRIOR COUNCIL ACTION:

On May 6, 2008, the El Paso City Council approved ordinances 16877, 16878, and 16880. These ordinances provided for reductions of various development fees in Title 18, 19, and 20 within the Tax Increment Reinvestment Zone No. 5.

ORDINANCE _____

AN ORDINANCE PROVIDING FOR A ONE HUNDRED PER CENT REDUCTION OF CERTAIN FEES SPECIFIED IN TITLE 18, TITLE 19, AND TITLE 20 OF THE EL PASO CITY CODE FOR A PERIOD OF TEN YEARS FOR PROPERTY DEVELOPMENT LOCATED IN THE DOWNTOWN 2015 PLAN AREA.

WHEREAS, the Downtown 2015 Plan was adopted by the El Paso City Council on October 31, 2006, and incorporated into the City of El Paso's Comprehensive Plan entitled *The Plan for El Paso* pursuant to the provisions of Section 213.002 of the Texas Local Government Code; and,

WHEREAS, the Downtown 2015 Plan serves as a study area and guide for the future growth and development of the downtown area to promote public health, safety, and welfare while supporting revitalization activities for redevelopment in the Downtown Redevelopment Districts; and,

WHEREAS, the downtown area is considered the economic heart of El Paso, Texas and its vibrancy is key to the investments made throughout the community;

WHEREAS, the El Paso City Council has determined that a revitalization strategy is necessary to address the critical needs of the downtown area in order to foster and support economic growth and opportunity and to ensure new investments will market the area as a thriving place to work, live and visit;

WHEREAS, the El Paso City Council has determined that part of the strategy for the revitalization of downtown is to provide financial incentives for property development and redevelopment within the downtown area; and,

WHEREAS, the El Paso City Council has determined that providing for a one hundred per cent reduction in property development fees will encourage development within the downtown area;

NOW; THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That the fees established by the El Paso City Code and specified in the attached Exhibit A are hereby reduced by one hundred percent for applications pertaining to or permits for work to be done at property area located within the Downtown 2015 Plan as shown in the attached Exhibit B.

Section 2. That the reduction of fees provided for in Section 1 shall be for a period of ten years and shall expire on March 26, 2022.

Section 3. That should additional land be added to the Downtown 2015 Plan after the date this ordinance is adopted, the land added shall also be entitled to the one hundred per cent reduction for the duration of the reduction of fess as provide in Section 2.

Section 4. That the effective date of this ordinance is March 27, 2012.


