**A RESOLUTION CALLING A SPECIAL ELECTION IN THE CITY OF EL PASO FOR THE SUBMISSION OF A MEASURE TO BE HELD WITHIN THE CITY ON MAY 9, 2009; AND MAKING PROVISIONS FOR THE CONDUCT OF THE ELECTION.**

WHEREAS, in accordance with Section 3.11 of the El Paso City Charter, an initiative petition ordinance was filed with the City Clerk, and the City Clerk certified this petition on November 14, 2008; and

WHEREAS, in accordance with Section 3.11 of the Charter, a second identical initiative petition ordinance was filed with the City Clerk, and the City Clerk certified this petition on January 23, 2009.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That pursuant to the Texas Election Code, as amended, a special election will be held on Tuesday, May 9, 2009 in the City of El Paso for the purpose of submitting the following measure to the qualified voters. Official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote for or against the measure with the ballots to contain such provisions, markings, and language required by law, and with such measure to be expressed substantially as follows:

**ADOPTION OF AN ORDINANCE OF THE CITY OF EL PASO**  
text of the ordinance

Adoption of an ordinance titled "An ordinance of the City of El Paso, Texas, transferring the rate making authority and changing the rate of the municipal utility drainage system," and specifically providing as follows:

WHEREAS, the City of El Paso ("El Paso") previously established a Municipal Drainage Utility System via Ordinance No. 16668; and

WHEREAS, the citizens of El Paso have clearly voiced the opposition of the Municipal Drainage Utility System and the fees imposed for its operation; and

WHEREAS, the City, in deference to the views of its Citizens, wishes to restructure and reduce the fees imposed for the operation of the Municipal Drainage Utility System; and

WHEREAS, the City recognizes state law prohibits it from altogether dissolving the Municipal Drainage Utility System until it has operated substantially continuously for five years; and

WHEREAS, the City retains the authority to transfer operation of the Municipal Drainage Utility System from the Public Service Board back to City Council and to reduce the rate for the drainage utility.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section I. Definitions.

“Board” means that certain board of trustees known as the “Public Service Board” established by the City pursuant to Section 1502.070 of the Texas Government Code and charged with having complete authority and control of the management and operation of the water and wastewater system of the City, as “City” means the City of El Paso, Texas, a Texas Home Rule Municipality.

“System” means the Municipal Drainage Utility System established by Ordinance 16668 and encompasses the complete drainage system of the City as it now exists and may be improved, added to, or extended hereafter, there being included in such term all drainage facilities now or hereafter owned or operated.

Section II.

1. Section III D of Ordinance 16668 is hereby rescinded. The authority and control of the management and operation of the system is hereby transferred from the Board to the City. The System shall be operated by the City Manager subject to the control and direction of City Council.
2. No monthly stormwater fee shall be imposed on any improved parcel within the City of El Paso or on any customers of the Board until further action by the City of El Paso acting through its City Council.
3. All fees and charges of the Municipal Drainage Utility System and all fees for storm water drainage are hereby suspended until further action by the City of El Paso acting through its City Council.
4. This Ordinance shall take effect immediately upon its adoption.
5. The City Manager is authorized to execute documents and take all appropriate action to give effect to this Ordinance.

2. That such election shall be held at the precincts and the polling places designated in Exhibit "A" or such other locations as may be designated prior to the election by the City

Council, attached hereto and made a part hereof for all purposes, and said polling places shall open at 7 a.m. and remain open until 7 p.m. on the day of the election.

3. That Richarda Duffy Momsen, the City Clerk of the City of El Paso, shall be the clerk for early voting, and Javier Chacon, County Elections Administrator, shall be the deputy clerk for early voting for said City election. The County Courthouse, 500 E. San Antonio, is hereby designated as the main early voting polling place for such election. In addition, early voting may also occur at such branch early voting polling places as are designated herein or otherwise designated by the El Paso County Elections Administrator and posted at city hall by the City Clerk, and the City Clerk is authorized to administratively designate the location for item q below, as recommended by the El Paso County Elections Administrator. The hours for early voting by personal appearance, including early voting on Saturday, May 2, 2009 and Sunday, May 3, 2009, shall be authorized for such election as follows:

Early voting shall be held weekdays from Monday, April 27 2009, through Tuesday, May 5, 2009, including on Saturday, May 2, 2009 and Sunday, May 3, 2009 only at the branches identified below as: b, c, e, f, g, i, j, k, m, o, and q. There is NO voting on Saturday, April 25, 2009 and Sunday, April 26, 2009. The hours for early voting are as noted below.

Specific listing of the hours of voting for weekdays April 27, 2009 – May 1, 2009: Additionally, for locations marked with an asterisk (\*), the hours of voting on Saturday, May 2, 2009 are from 9:00 am – 6:00 pm, and on Sunday, May 3, 2009 from 12:00 pm – 5:00 pm. The hours of voting for all locations on Monday, May 4, 2009 and Tuesday, May 5, 2009 are from 7:00 am – 7:00 pm.

In addition, mobile voting stations shall also be authorized and used for early voting, as set forth in Exhibit B, which includes the respective hours for early voting by personal appearance at these stations. The City Clerk is authorized to make corrections or revisions to the list of mobile voting stations in Exhibit B and to all election notices regarding the early voting locations and the mobile voting stations, and the dates and times for such voting.

Applications for early voting by mail shall be submitted to the Early Voting Clerk no earlier than March 10, 2009 and no later than the close of business on May 1, 2009, at the following address:

4. A special canvassing board shall be appointed by the Mayor, or by the Council, as provided by law to count and canvass all early votes and ballots cast at said election.

5. That electronic voting machines shall be used for voting at the regular polling places in such election, and for the casting of early ballots by persons voting early by personal appearance and by mail.

6. That such election shall be held in the manner and form prescribed by the laws of the State of Texas, and at such election all qualified voters in the City are authorized to vote.

7. That by approving and signing this resolution, the Mayor officially confirms as his action, all matters recited herein which by law come within his jurisdiction.

8. A substantial copy of this resolution shall serve as proper notice of said election.

9. The City Clerk shall give notice of such election by posting a notice of such election in English and Spanish in the Office of the City Clerk as provided by law and by publishing a copy of said notice in both English and Spanish in a newspaper of the City as required by law.


