RESOLUTION

WHEREAS, in accordance with Chapter 18.50 of the El Paso City Code, the Building and Standards Commission of the City of El Paso, by Order dated the 31st day of August, 2005, after due notice and hearing, issued an order to RAYMOND P. LOPEZ, PEDRO RAMON LOPEZ, JR., JOSE ALMANZA AND JOSE ALMANZA, JR. BEATRIC A. LUDENS, MARIA LUISA ALMANZA, GLORIA ALMANZA, LUPE ALMANZA, ARTURO ALMANZA, and ESPERANZA ALMANZA, record Owners of the hereinafter described property that the Buildings be demolished within thirty (30) days and to clean the premises of all weeds, trash, and debris all within thirty (30) days, and the Owners and any mortgagee or lienholder having failed after due notice to comply with such ORDER, the Street Department of the City of El Paso has been ordered to proceed to demolish the Buildings and clean the premises of all weeds, trash, and debris.

WHEREAS, the Director for the Development Services Department has reported the cost of doing such work in the amount hereinafter set forth;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That the City Council determines the actual cost of demolishing the Buildings and cleaning the premises of all weeds, trash and debris from the property, more particularly described as:

Lot 11, Block 2, Heatfield & Hudspeth Subdivision of the Cotton Addition Subdivision, an addition to the City of El Paso, El Paso County, Texas, according to the map thereof on File in Book 4, Page 15, Plat Records of El Paso County, municipally known and numbered as 106 Hudspeth Place, El Paso, Texas.

to be \$20,192.13, performed by the Street Department of the City of El Paso, and \$1,084.00, performed by the City Clerk's Office and Development Services Department, making a total of \$21,276.13. The City Council finds that the work was completed on the 12th day of May, 2006, and approves the costs.

2. That the City Council, in accordance with Texas Local Government Code §214.001(n), declares the above total amount of TWENTY-ONE THOUSAND TWO HUNDRED SEVENTY-SIX AND 13/100 DOLLARS (\$21,276.13) to be a lien on the above-described property.

3. That the City Clerk is directed to give notice of this lien by filing a copy of this Resolution for record with the County Clerk.

4. That all records of the City Clerk's Office relating to the proceeding against the above-described property are made a part of this Resolution by reference.
