El Paso Zoo Department recommends acceptance of El Paso Zoological Society donation of \$100,000.00 to supplement city funding toward contracted services for new Zoo Master Plan.

El Paso Zoo Department has completed the previous Master Plan and related projects as part of the 2000 QOL Bond Issuance. The Zoo now looks to a longer range plan for development and operations as a guide for next 20 year period. The City has allocated an initial \$100,000.00 toward contracted services. The Zoo and Purchasing departments have solicited and received qualifications for services related to this Master Plan. The Zoo Department recommends acceptance of the donation to provide funding to complete the needed tasks as outlined by Zoo staff for a new Master Plan.

SELECTION SUMMARY:

The El Paso Zoo Society is a non profit organization dedicated to providing funding and support for the El Paso Zoo. This donation amount is available currently and will be deposited upon acceptance by City of El Paso and completion of necessary actions.






