Approve an Ordinance amending Title 12 (Vehicles and Traffic) to amend Chapter 12.88.180 (No Stopping or Standing – Tow Away Zone) to remove Paragraph 111 (Oregon Street between Yandell Drive and Glory Road), and to amend Chapter 12.88.030 (Parking Prohibited At All Times) to add Oregon Street between Yandell Drive and Glory Road, the penalty being as provided in Section 12.84.010 and Chapter 12.85 of the El Paso City Code.

Removal of "No Stopping or Standing – Tow Away Zone" for "Parking Prohibited At All Times", no signage will be erected, instead, yellow paint will be used along Oregon Street curb lines between Glory Road and Yandell Avenue.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC) TO AMEND CHAPTER 12.88.180 (NO STOPPING OR STANDING – TOW AWAY ZONE) TO REMOVE PARAGRAPH 111 (OREGON STREET BETWEEN YANDELL DRIVE AND GLORY ROAD), AND TO AMEND CHAPTER 12.88.030 (PARKING PROHIBITED AT ALL TIMES) TO ADD OREGON STREET BETWEEN YANDELL DRIVE AND GLORY ROAD, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), is amended to delete the following paragraph (number 111):

111. Oregon Street between Yandell Drive and Glory Road, both sides;

and to re-number paragraph numbers 112 and 113 as numbers 111 and 112, respectively.

**Section 2.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at times on certain streets), of the El Paso City Code, is amended to add the following paragraph (number 375):

375. Oregon Street between Yandell Drive and Glory Road, both sides.

**Section 3.** Except as herein amended, Title 12, Chapter 12.88, of the El Paso City Code shall remain in full force and effect.




