

**FIRST AMENDMENT TO  
AFFILIATE EVENT AGREEMENT**

This First Amendment to 2007 Affiliate Event Agreement (the "Agreement") is entered into this \_\_\_\_ day of \_\_\_\_\_ 2008, by and between the City of El Paso, a municipal corporation situated in El Paso County, Texas ("City") and The Texas Round-Up, Inc. ("Corporation").

**WHEREAS**, the City and the Corporation entered into an Agreement on February 13, 2007 to allow the El Paso Ciclo Via to be recognized as an official Affiliate Event of the 2007 Texas Round-Up and for the City of El Paso to actively promote the Governor's Challenge Program to improve the health of Texas through education and promotion of physical activity and healthy living;

**WHEREAS**, the City and the Corporation desire to renew the Affiliate Event Agreement and to simplify future renewals;

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

1. That Paragraph 1 of the Agreement is modified to read as follows:
  1. This Agreement shall be effective from the date first set forth above and will automatically and annually renews at each Scheduled Affiliate Event to continue until the next Scheduled Affiliate Event date unless either party provides thirty (30) days prior written notice to the other party.
2. Except as herein provided, all terms and conditions of the 2007 Affiliate Event Agreement dated February 13, 2007 shall remain in full force and effect.


