7.30.030 – Terms of office

B. Each term shall commence on the expiration date of the term of the immediate predecessor; provided, however, that appointments to vacancies occurring other than by expiration of a member's term of office (such as upon a member's death, resignation, or removal) shall be filled by nomination and appointment by City Council for the remainder of the unexpired term. The members of the Animal Welfare Advisory Committee shall be subject to the term limitation provisions contained in Section 2.04.050 of the El Paso City Code.



AN ORDINANCE AMENDING TITLE 7 (ANIMALS), CHAPTER 7.30 (ANIMAL WELFARE ADVISORY COMMITTEE), SECTION 7.30.030 (TERMS OF OFFICE) OF THE EL PASO CITY CODE TO ESTABLISH TERM LIMITS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 7 (Animals), Chapter 7.30 (Animal Welfare Advisory Committee), Section 7.30.030 (Terms of office.), Subsection B of the El Paso City Code, shall be and hereby is amended in its entirety to read as follows:

7.30.030 - Terms of office.

B. Each term shall commence on the expiration date of the term of the immediate predecessor; provided, however, that appointments to vacancies occurring other than by expiration of a member's term of office (such as upon a member's death, resignation, or removal) shall be filled by nomination and appointment by City Council for the remainder of the unexpired term. The members of the Animal Welfare Advisory Committee shall be subject to the term limitation provisions contained in Section 2.04.050 of the El Paso City Code.

**Section 2.** This ordinance shall take effect on April 1, 2011.

**Section 9.** Except as expressly herein amended, Title 7 (Animals) of the El Paso City Code shall remain in full force and effect.
