Approve an Ordinance authorizing the City Manager to execute a quitclaim (tax resale) deed conveying all right, title and interest in:

Lots 21 through 29, Block 29, Highland Park Addition, being more particularly described in Volume 13, Page 8, Deed Records of El Paso County, Texas.

to **North Cotton Associates, L.L.C.**, in accordance with Section 34.05 (h) of the Tax Code. Section 34.05 (h) permits the City to sell a property for the total amount of the judgment and the sale of the property does not require the consent of each taxing entity entitled to receive proceeds from the sale.

BACKGROUND / DISCUSSION:


