AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III – PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE EL PASO CITY CODE TO DELETE THE PROHIBITION OF PARKING ON MILLS AVENUE BETWEEN OCHOA STREET AND VIRGINIA STREET, SOUTH SIDE; THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

This portion of Mills Avenue once had signs prohibiting parking because motorists were parking on an unapproved surface and at times damaging the chain-link fence. Recently the road was improved with sidewalk, curb, and gutter. The No Parking signs were not replaced and motorists began parking here. After evaluating this location we observed that these vehicles can safely park and not cause any conflicts. At this time, the Traffic Engineering Department finds that the parking restriction is no longer needed and recommend that this block of Mills be deleted from the schedule.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III – PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) OF THE EL PASO CITY CODE TO DELETE THE PROHIBITION OF PARKING ON MILLS AVENUE BETWEEN OCHOA STREET AND VIRGINIA STREET, SOUTH SIDE; THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets) of the El Paso City Code shall be and hereby is amended by deleting the following:

396. Mills Avenue between Ochoa Street and Virginia Street, south side;

Section 2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at all times on certain streets) of the El Paso City Code shall remain in full force and effect.




