**RESOLUTION AMENDING SCHEDULE C FOR  
THE CITY OF EL PASO FY 2009 BUDGET RESOLUTION RELATING TO  
CERTAIN FEES BY THE PARKS AND RECREATION DEPARTMENT**

WHEREAS, the City Council adopted the Budget Resolution for FY2009 on August 19, 2008; and

WHEREAS, paragraph 40 of the Budget Resolution provides that revisions or additions to the fees set forth in Schedule C, attached to the Budget Resolution, may be approved by simple resolution of the City Council; and

WHEREAS, on December 16, 2008, the Council adopted a resolution amending the fees for participation by senior citizens in certain programs of the Parks and Recreation Department; and

WHEREAS, the Council desires to amend the fees for participation by senior citizens in certain programs of the Parks and Recreation Department.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF EL PASO:

1. That the fee shall be zero dollars (\$0) for any "Senior Classes (55 years and older)" that are set forth on Schedule C of the Budget Resolution, as amended on December 16, 2008, for classes that have volunteer instructors and are held in the Senior Centers.
2. That Schedule C as amended by Council on December 16, 2008 shall otherwise remain unchanged and in full force.
