AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041, (SCHEDULE IV(A)-PARKING PROHIBITED DURING CERTAIN HOURS, SCHOOL DAYS ONLY), PARAGRAPH A, (NO PARKING 7:00 A.M. TO 4:00 P.M.) OF THE EL PASO CITY CODE, BY ADDING ANISE DRIVE, BETWEEN LEE TREVINO DRIVE AND MONTWOOD DRIVE, WEST SIDE ONLY. THE PENALTY BEING AS PROVIDED IN SECTION 12.85.110 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

A resident of Anise Drive submitted a petition to extend the existing no parking zone on the west side of Anise Drive between Frank Beard to Lee Trevino. The Traffic Engineering Division has reviewed the petition and concluded there is enough support from the property owners to prohibit parking on this portion of Anise. It is the recommendation of the Engineering Traffic Division that this portion of Anise be included in this ordinance.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041, (SCHEDULE IV(A)-PARKING PROHIBITED DURING CERTAIN HOURS, SCHOOL DAYS ONLY), PARAGRAPH A, (NO PARKING 7:00 A.M. TO 4:00 P.M.) OF THE EL PASO CITY CODE, BY ADDING ANISE DRIVE, BETWEEN LEE TREVINO DRIVE AND MONTWOOD DRIVE, WEST SIDE ONLY. THE PENALTY BEING AS PROVIDED IN SECTION 12.85.110 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041, (Schedule IV(A) - Parking prohibited during certain hours, School Days only), Paragraph A, (No Parking 7:00 a.m. to 4:00 p.m). of the El Paso City Code is amended by adding the following:

Anise Drive, between Lee Trevino Drive and Montwood Drive, westside only.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041, (Schedule IV(A) - Parking prohibited during certain hours, School Days only), Paragraph A, No Parking 7:00 a.m. to 4:00 p.m. of the El Paso City Code shall remain in full force and effect.

Anise Drive, between Lee Trevino Drive and Montwood Drive, west side only;

A resident of Anise Drive submitted a petition for restricting parking on the west side of Anise Drive from Lee Trevino Drive to Frank Beard Drive. We have reviewed the petition and concluded there is enough support from the neighborhood's property owners to prohibit parking on this portion of Anise Drive. The portion of Anise from Frank Beard to Montwood has existing signs with this parking restriction. At this time, we recommend this portion of Anise be included in the schedules.
