**SUBJECT:    ORDINANCE**

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III – PARKING PROHIBITED AT ALL TIME ON CERTAIN STREETS) OF THE EL PASO CITY CODE BY ADDING KERBEY AVENUE FROM OREGON STREET TO THE ALLEY EAST THEREOF, NORTH SIDE ONLY, AND FROM OREGON STREET TO A POINT 40 FEET EAST THEREOF, SOUTH SIDE ONLY AND FROM MESA STREET TO A POINT 17 FEET WEST THEREOF, SOUTH SIDE ONLY; THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

**BACKGROUND/DISCUSSION:**

The ordinance is being amended to allow for the removal of parking along portions of Kerbey Avenue to provide sufficient space for turning movement for Smart 101 Bus Service. The amendment will add parking restrictions on Kerbey Avenue from Oregon Street to the alley, north side only and from Oregon Street 40 feet, south side only and from Mesa Street 17 feet west, southside only. The Engineering Traffic Division recommends this amendment.



**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited at all time on certain streets) of the El Paso City Code shall be and hereby is amended by adding the following street to the streets presently listed:

Kerbey Avenue from Oregon Street to the alley east thereof, north side only, and from Oregon Street to a point 40 feet east thereof, south side only and from Mesa Street to a point 17 feet west thereof, south side only.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited at all time on certain streets) of the El Paso City Code shall remain in full force and effect.




