SUBJECT: ORDINANCE

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.010 (SCHEDULE I - ONE WAY STREETS) OF THE EL PASO CITY CODE TO DELETE PARAGRAPH 87. THE PENALTY IS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BACKGROUND/DISCUSSION:

The Engineering Traffic Division is recommending that the existing one way portion of River Avenue between Hawthorne Street to Lawton Drive be converted to allow for two way traffic. This portion of River Avenue was recently resurfaced and is now wide enough with two way traffic with no parking. The Traffic Division therefore recommends that this ordinance be amended.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.010 (SCHEDULE I – ONE WAY STREETS) OF THE EL PASO CITY CODE TO DELETE PARAGRAPH 87. THE PENALTY IS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.010 (Schedule I—One Way Streets) of the El Paso City Code shall be and hereby is amended to delete the following paragraph:

87. River Avenue, Westbound from Hawthorne Street to Lawton Drive.

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.010 (Schedule I – One Way Streets.) of the El Paso City Code, shall remain in full force and effect.


