AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.32 (PEDESTRIANS), SECTION 12.32.070 (CROSSWALK ON PIEDRAS STREET AT GRANT AVEUNE) OF THE EL PASO CITY CODE BY REPEALING SECTION 12.32.070 (CROSSWALK ON PIEDRAS STREET AT GRANT AVEUNE); THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BACKGROUND/DISCUSSION:

This ordinance is being amended to repeal Title 12 (Vehicles), Chapter 12.32 (Pedestrians) Section 12.30.70 (crosswalk on Piedras Street at Grant Avenue) to allow pedestrians to use existing crosswalks and pedestrian signals on the north side of the intersection. The Engineering Traffic Division recommends this ordinance be amended.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.32 (PEDESTRIANS), SECTION 12.32.070 (CROSSWALK ON PIEDRAS STREET AT GRANT AVEUNE) OF THE EL PASO CITY CODE BY REPEALING SECTION 12.32.070 (CROSSWALK ON PIEDRAS STREET AT GRANT AVEUNE); THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.32 (Pedestrians), Section 12.32.070 (Crosswalk on Piedras Street at Grant Avenue) of the El Paso City Code shall be and hereby is amended by repealing Section 12.32.070 (Crosswalk on Piedras Street at Grant Avenue).

Section 2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Pedestrians) of the El Paso City Code shall remain in full force and effect.


