Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV – Speed Limits) Paragraph F (Thirty-Five Miles Per Hours), of the El Paso City Code, to add new speed limits, the penalty being as provided in Chapter 1.08 (General Penalty) of the El Paso City Code.

This ordinance is to establish speed limits on the listed streets. The 35 MPH speed limit is based on design standards and street classification. All three streets are classified as "Collector Arterials".

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV – SPEED LIMITS) PARAGRAPH F (THIRTY-FIVE MILES PER HOURS), OF THE EL PASO CITY CODE, TO ADD NEW SPEED LIMITS, THE PENALTY BEING AS PROVIDED IN CHAPTER 1.08 (GENERAL PENALTY) OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV – Speed Limits), Paragraph 12.88.150(F) (Thirty five miles per hour), is hereby amended to add the following:

12.88.150 F. Thirty five miles per hour:

Charles Foster Avenue  
Ralph Seitsinger Drive  
Tim Foster Street

Section 2. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
