It is requested that the City Manager be authorized to establish the funding sources and make any necessary budget transfers and execute any and all documents necessary for execution of this award.

Work under this unit price contract is only estimated value and will be ordered, performed, invoiced, and paid by measure quantity. The actual cost of this contract may be higher or lower than the total estimated value and will be the sum total of unit prices at the end of the contract term.

As a part of this award, upon the review of the City Attorney, the City Engineer may without further authorization from City Council approve contract changes which are necessary for proper execution of the work and carrying out the intent of the project, which are in accordance with applicable law, do not make changes to the prices and are within the appropriate budget.

This is a low bid, unit-price contract. The Engineering & Construction Management Department recommends award as indicated to the lowest responsive and responsible bidder.

BACKGROUND / DISCUSSION:

The Park Pond Improvements Group 2 bid package consists of converting 3 ponds into park ponds. The locations are Skyline Park, Edgemere/Freeport Pond and Vocational Pond. The award of this bid package is separated into 2 bid components. For this component we recommend award of Skyline Park

and Vocational Pond to Medlock Commercial Contractors, LLC. Edgemere/Freeport Pond will be awarded separately.

The City of El Paso will pay an estimated 60% and the El Paso Water Utilities Storm Water will pay an estimated 40% of the costs.

For Skyline Park (Base Bid I), the improvements consist of installing a new irrigation system, sod, trees, shrubs, boulders, and landscape rock. New ADA complaint concrete sidewalk and wheelchair ramps will be installed. Park amenities include park benches, pet waste stations, and trash receptacles. Storm water improvements consist of reconstructing drainage flume structures and placing flood warning signs.

For Vocational Pond (Base Bid III), the improvements consist of installing a new irrigation system, sod, trees, shrubs, and landscape rock. Site work improvements consists of new ADA compliant concrete sidewalk, wheelchair ramps, curb and gutter, concrete driveways, asphalt pavement repair, and installation of a new decorative wrought iron fence. Park amenities include ADA tables with chairs, park benches, pet waste stations, and trash receptacles. Storm water improvements consist of pond excavation, reconstructing drainage flume structures, headwalls, erosion control rip rap and gabion structures and placing pond depth gauge and flood warning signs.

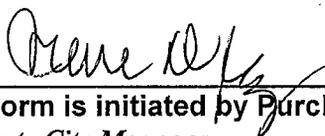

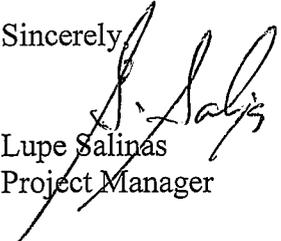

PARK POND IMPROVEMENTS GROUP 2

SOLICITATION No. 2013-108

SCOPE OF WORK

(SKYLINE PARK, EDGEMERE/FREEPORT POND, VOCATIONAL POND)

BASE BID 1: SKYLINE PARK

Site, Storm Drainage, Park, and Landscaping improvements are proposed for approximately 9.89 acres of Skyline Optimist Youth Park which is located on 5050 Yvette Ave. in El Paso, Texas. Construction improvements under this project include earthwork excavation. Proposed site improvements include 950 SY of 4" concrete sidewalk, 1 EA of ADA compliant wheelchair ramp (Type C), 9,710 SF of future parking lot screenings, and 910 LF of header curb. In addition, proposed storm drainage improvements include 2 EA of 5' covered flume structures and 1 EA of flood warning sign. Additionally, stormwater pollution prevention measures are required as part of this base bid Scope of Work.

Proposed Park and Landscaping improvements include 3 EA of trash receptacle assemblies, 2 EA of pet waste stations, 6 EA of trash receptacle assemblies, 4 EA of bench assemblies, 43,400 SF of rock mulch, 61,750 SF of screenings, 128 EA of two inch caliper trees, 433 EA of five gallon shrubs, 442 EA of one gallon shrubs, 303,060 SF of hybrid bermuda sod, 56 EA of boulders, and 1 LS of subsurface irrigation system.

Option No. 1

Option No. 1 includes additional site furnishings which include 1 EA of trash receptacle assemblies, 2 EA of ADA tables with chairs, and 1 EA of bench assemblies.

Option No. 2A

Option No. 2A includes an irrigation main addition which includes 6" meter and backflow pressure reducer, removal of existing pavement, 6" PVC water main line, trenching, backfill, and asphalt pavement patchwork.

Option No. 2B

Option No. 2B includes an irrigation main addition which includes 6" meter and backflow pressure reducer, removal of existing pavement, 8" PVC water main line, trenching, backfill, and asphalt pavement patchwork.

Option No. 2C

Option No. 2C includes an irrigation main addition (located behind an existing building) which includes 6" meter and backflow pressure reducer, removal of existing pavement, 6" PVC water main line, trenching, backfill, and asphalt pavement patchwork.

BASE BID 2: EDGEMERE/FREEPORT POND

Site, Storm Drainage, Park, and Landscaping improvements are proposed for Edgemere/Freeport Pond which is located on 10705 Edgemere Blvd., between Edgerock Dr. and Freeport Dr. Construction improvements under this project include the removal, relocation, and/or adjustment of street signage, drainage structures, and the selective demolition of concrete, pavement, curb, and guard fence. Proposed site improvements include 26 SY of asphalt pavement patchwork, 10 LF of standard curb and gutter, 25 LF of mountable curb and gutter, 18 SY of reinforced concrete driveway, 55 SY of concrete sidewalk, 2,950 SF of stabilized screenings, 61 SY of colored concrete sidewalk, and 105 SY of colored concrete plaza, and 745 LF of header curb. In addition, the site improvements also include 50 LF of four foot high decorative wrought iron fence, 58 LF of four foot wrought iron fence embedded in a rockwall base, 40 PR of stacked rockwall, 1 LS of rockwall mortar repair, 23 LF of metal beam guard fence, 2 EA of ADA compliant wheelchair ramp (Type B), 2 EA of ADA compliant wheelchair ramp (Type C), and 1 EA 25-ft wide vehicular access swing gate.

Proposed storm drainage improvements include earthwork excavation for existing retention pond improvements and creation of a park/pond facility, installation of 1 EA of pedestrian flume structure, 130 SY of reinforced concrete flume, 45 SY of gabion matt, 1 EA of a 14-ft high pond depth gauge, and 1 EA of flood warning signage. Proposed Park and Landscape improvements include 1 EA of trash receptacle assembly, 1 EA of pet waste station, 645 SF of rock mulch, 715 SF of screenings, 46 EA of two inch caliper trees, 7 EA of three inch caliper trees, 55,530 SF of hybrid bermuda sod, and 1 LS of subsurface irrigation system. Additionally, stormwater pollution prevention measures are required as part of this base bid Scope of Work.

Option No. 1

Option No. 1 includes perimeter rockwall reconstruction improvements along a portion fronting Edgerock Dr. and Freeport Dr. which include 360 LF of rockwall removal and disposal to a depth of nine inches and 18 PR of rockwall construction to a depth of nine inches.

Option No. 2

Option No. 2 includes perimeter wrought iron fencing construction along a portion fronting Edgerock Dr. and Freeport Dr. which include 360 LF of wrought iron fencing with concrete cored footings along the existing sidewalk.

Option No. 3

Option No. 3 includes additional site furnishings which include 1 EA of trash receptacle assembly, 1 EA of pet waste station, 4 EA of ADA tables with chairs, 4 EA of park benches, and 1 EA of flood warning signage.

BASE BID 3: VOCATIONAL POND

Site, Storm Drainage, Park, and Landscaping improvements are proposed for Vocational Pond which is located at 7464 Balsam Dr., on the southwestern intersection of Balsam Dr. and Mimosa Ave. Construction improvements under this project include the removal, relocation, and/or adjustments of street signage, drainage structures, and the selective demolition of concrete, pavement, curb, and guard fence. Proposed site improvements include 190 SY of asphalt pavement patchwork, 1,000 LF of standard curb and gutter, 315 SY of reinforced concrete driveway, 1,350 SY of concrete sidewalk, 45 SY of reinforced concrete sidewalk, 40 LF of four foot high decorative wrought iron fence, 46 LF of four foot high decorative wrought iron fence embedded in a rockwall base, 1 EA of ADA compliant wheelchair ramp (Type A), 3 EA of ADA compliant wheelchair ramp (Type C), 25,600 SF of stabilized screenings for walkway, and 3,995 LF of header curb.

Proposed storm drainage improvements include earthwork excavation for existing retention pond improvements and creation of a park/pond facility, installation of 1 EA five foot wide covered flume structure, 3 EA of seven and a half foot wide covered flume structure, 50 SY of reinforced concrete flume adjacent to covered flume structures, 330 SY of gabion mattress swale, 70 PR of twelve inch thick mortared rock rip-rap, 1 EA headwall structure for an existing forty-two inch RC pipe, 1 EA safety rack for forty two inch RC pipe headwall structure, and 1 EA safety rack for an existing twenty four inch RC pipe headwall structure. In addition, improvements also include 1 EA outlet headwall structure for a six inch blow off line from Well No. 420, 22 SY of reinforced concrete flume along the pond slope, 1 EA ten foot high pond depth gauge, and 3 EA of flood warning sign. Utility adjustments include the removal and proper disposal of 110 LF of six inch asbestos concrete pipe, 98 LF of six inch PVC (C-900) pipe, 18 LF of six inch ductile iron (Class 250) pipe, 1 EA flap valve, and 1000 LB of additional fittings.

Proposed Park and Landscape improvements include 2 EA of trash receptacle assembly, 2 EA of pet waste station, 2 EA of ADA tables with chairs, 2 EA of park bench assemblies, 17,375 SF of rock mulch, 71,500 SF of screenings, 151 EA of two inch caliper trees, 12 EA of three inch caliper trees, 447 EA of five gallon shrubs, 395 EA of one gallon shrubs, 134,767 SF of hybrid bermuda sod, 112,637 SF of hydromulch grass seeding, 19,725 SF of hydromulch pond seeding, 237,240 SF of hydromulch wildflower seeding, and 1 LS of subsurface irrigation system. Additionally, stormwater pollution prevention measures are required as part of this base bid Scope of Work.

Alternate No. 1 (To Bid Item 55)

Alternate No. 1, to replace Bid Item 55 (hydromulch grass seeding), includes 112,637 SF of hybrid bermuda sod.

Option No. 1

Option No. 1 includes additional site furnishings which include 3 EA of trash receptacle assembly, 1 EA of pet waste station, 1 EA of ADA tables with chairs, 5 EA of park bench assemblies, and 3 EA flood warning signage.

Option No. 2

Option No. 2 includes outdoor fitness improvements which include 1 EA of exercise equipment stations.

Prior to commencement of any work, the Contractor shall submit and obtain approval from City of El Paso, Engineering & Construction Management Department, for the Sequence of Construction, Schedule of Work, and Haul/Waste Route to an approved disposal site. Traffic Control Plan must be submitted and approved, if applicable. Contractor shall provide written approved documentation from the owner or operator of the waste site.

The description of this scope of work as shown above is only a general overview of this project. Contractor shall refer to the project plans and specifications for further information.

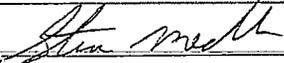
Contract and Bid Award

- All awards will be to the lowest responsive responsible bidder for that award
- The Owner reserves the right to award separate contracts for Base Bid 1, Base Bid 2, and Base Bid 3 with accepted associated options and alternates. Therefore, it is possible for this bid to be awarded to three separate bidders.
- If Option(s) of Base Bid 1 is/are awarded, it will go to the bidder that was awarded Base Bid 1.
- If Option(s) of Base Bid 2 is/are awarded, it will go to the bidder that was awarded Base Bid 2.
- If Option(s) and Alternate of Base Bid 3 is/are awarded, it will go to the bidder that was awarded Base Bid 3.

Determination of Lowest Responsive Responsible Bid

Determination of the lowest responsive responsible bid may be based on; 1) the individual bids for Base Bid 1, Base Bid 2, Base Bid 3; or 2) any combination of Base Bids, Options, and Alternates that is most advantageous to the City based upon the available funding.

- If a bidder decides not to submit a bid for a certain base bid with associated options and alternates bidder needs to write the word "No Bid Submitted" on bid proposal form where that particular base bid is shown.
- Bidders who submit a bid for a particular base bid must also submit a bid for all associated options and alternates tied to that particular base bid.
- If a bidder submits a bid for a particular base bid but not for associated option and/or option tied to that base bid bidder **will be deemed non responsive**.

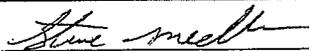
- The owner shall issue concurrent notice to proceed for all base bids, options and alternates.

NOTE: The quantities shown in the unit price schedule are ESTIMATES ONLY. They are shown here only for the purpose of comparing bids as an expected total expenditure. The City, at its sole discretion, will direct exactly how many actual units will be placed, and will pay for only those units that are ordered and accepted. No payments will be made regarding the estimated quantities, they are estimates only.

Estimates are minimums, but not guaranteed minimums, and the contract cost can increase so long as the unit costs remain the same and the increased funds are appropriated in the budget. Line item entries shall prevail over sum total entries. When discrepancies exist between unit prices and corresponding extended prices, unit prices shall prevail.

EACH PROPOSAL MUST BE SUBMITTED ON THE PRESCRIBED FORM AND all blank spaces on the proposal form for proposal prices must be filled in, in ink or typewritten. FAILURE TO FILL IN ALL BLANK SPACES SHALL CAUSE THE BID PROPOSAL TO BE DEEMED NOT RESPONSIVE AND BID PROPOSAL WILL NOT BE CONSIDERED IN DETERMINING THE LOWEST RESPONSIBLE BIDDER.

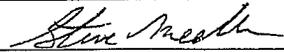
