Environmental Services Department recommends award to the following bidders for solicitation 2012-191R Veterinarian Services-Animal Shelter for a 3-year total of \$705,000.00.

**BACKGROUND / DISCUSSION:**

Environmental Services Department is looking for Veterinarian services to be provided for the City of El Paso and it is required that a Veterinarian is in place at all times. Environmental Services Department has reviewed solicitation 2012-191R Veterinarian Services and recommends the contract be awarded to Bernie Ray Page, DVM (V1) for an estimated annual amount of \$150,000; Lawrence Koym, DVM (V2) for an estimated annual amount of \$40,000; Alvaro Medina, DVM (V3) for items for an estimated annual contract of \$30,000 and Dennis W. Flosi, DVM (V4) for an estimated annual amount of \$15,000. These verterinarians meet the specifications required.

**SELECTION SUMMARY:**

Solicitation was advertised on 3/20/12 and 3/27/12. The postcards were mailed out on 3/20/12. The solicitation was posted on City website on 3/20/12. The email (Purmail) notification was sent out on 3/20/12. A total of forty-eight bidders including forty-five local vendors were solicited. A total of four bids were received including three being local vendors.

**PROFESSIONAL SERVICES AGREEMENT**

This Professional Services Agreement (“Agreement”), made this \_\_\_\_\_ day of \_\_\_\_\_, 2012, by and between the **CITY OF EL PASO**, hereinafter called “City,” and Bernie Ray Page, DVM, hereinafter referred to as "Contractor," witnesseth:

1.     **HIRING OF CONTRACTOR.**     The City hereby agrees to retain the Contractor and the Contractor agrees to perform professional veterinary services for the City’s Environmental Services Department. The Contractor shall complete the Scope of Services as further described in **Attachment “A”**.

1.1     The City will ensure that all information regarding policy and procedures, quality assurance site reviews, etc., will be provided to the Contractor for review.

1.2     **PROOF OF CITIZENSHIP.**     Contractor agrees to comply with the Immigration Reform and Control Act. Contractor agrees to complete all necessary forms or documents including Form I-9 and to provide proof of United States citizenship or lawful residency and work status within three days of the execution of this Agreement.

1.3     **LOCATION OF PERFORMANCE.**     Such services shall be performed in the City and County of El Paso, State of Texas.

2.     **PAYMENT TO CONTRACTOR.** The City shall pay to the Contractor an amount not to exceed **FOUR HUNDRED FIFTY THOUSAND AND 00/100 DOLLARS (\$450,000.00)** for the entire term of this contract, which equals **ONE HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$150,000.00)** for each separate twelve month period during the term for all services performed pursuant to this Agreement. The Contractor’s rates for the performance of all listed services is attached hereto as **Attachment “B”**.

2.1 Contractor shall bill the City not more often than monthly, through written invoices pursuant to **Attachment "C"**.

2.1.1 Each invoice shall contain at a minimum, the current invoiced amount.

2.1.2 The City agrees to pay invoices for all services performed as soon as reasonably possible, but not later than thirty (30) days from receipt. Upon dispute, however, the City may, upon notice to the Contractor, withhold payment to the Contractor for the amount in dispute only, until such time as the exact amount of the disputed amount due the Contractor is determined. The total amount paid to Contractor shall not exceed Contractor's fee proposal, except by written amendment to this Agreement, executed by both parties.

2.2 **COSTS NOT ENUMERATED.** Except as specifically set forth in this Agreement and its attachments, all costs related to the completion of the services requested herein shall be borne by the Contractor and not passed on to the City or otherwise paid by the City, unless a written amendment to this Agreement is executed by both parties allowing for additional costs.

3. **TERM.** This Agreement shall be in full force and effect for a thirty-six month term commencing on May 1, 2012 and ending on April 30, 2015.

3.1 Should Contractor be in full compliance with this Agreement, the City, in its sole discretion may offer Contractor a twelve (12) month extension of this Agreement, under terms acceptable to both parties in writing.

4. INDEPENDENT CONTRACTOR. Nothing contained herein shall be construed as creating the relationship of employer and employee between the City and the Contractor. The Contractor shall be deemed at all times to be an independent contractor.

5. INSURANCE. Contractor agrees to carry his own professional liability insurance in the amount of FIVE HUNDRED THOUSAND (500,000.00) AND NO/100 DOLLARS, and to provide proof of such insurance to the Environmental Services Department prior to commencement of services pursuant to this Agreement. Said professional liability insurance policy limitations shall be in accordance with the accepted standards of the local medical community. The proof of coverage shall show the policy to be in full force and effect at all times during this Agreement. Failure to maintain said insurance shall be considered a material breach of this Agreement.

5.1 Contractor shall maintain said insurance with a solvent insurance company authorized to do business in Texas. Contractor shall file a copy of the policy binder and a certificate of insurance with the Environmental Services Department within ten (10) days of execution of this Agreement. Such policy or certificate shall provide that the insurance cannot be cancelled or the amount of coverage changed without thirty (30) days prior written notice to the Environmental Services Department.

6. INDEMNIFICATION. CONTRACTOR SHALL INDEMNIFY, DEFEND AND HOLD THE CITY OF EL PASO AND ITS OFFICERS, AGENTS, VOLUNTEERS AND EMPLOYEES COMPLETELY HARMLESS FROM AND AGAINST ANY AND ALL LIABILITIES, LOSSES, SUITS, CLAIMS, JUDGMENTS, FINES OR DEMANDS ARISING BY REASON OF INJURY OR DEATH OF ANY PERSON OR DAMAGE TO ANY PROPERTY,

INCLUDING ALL REASONABLE COSTS FOR INVESTIGATION AND DEFENSE THEREOF (INCLUDING, BUT NOT LIMITED TO ATTORNEY FEES, COURT COSTS AND EXPERT FEES), OF ANY NATURE WHATSOEVER ARISING OUT OF OR INCIDENT TO THIS CONTRACT, WHICH ARE THE RESULT OF ACTS OF NEGLIGENCE OF CONTRACTOR OR CONTRACTOR'S AGENTS OR EMPLOYEES. CONTRACTOR SHALL GIVE TO THE CITY REASONABLE NOTICE OF ANY SUCH CLAIMS OR ACTIONS. CONTRACTOR SHALL USE LEGAL COUNSEL REASONABLY ACCEPTABLE TO THE CITY IN CARRYING OUT ITS OBLIGATIONS HEREUNDER. THE PROVISIONS OF THIS SECTION SHALL SURVIVE THE EXPIRATION OR EARLY TERMINATION OF THIS CONTRACT.

7. **TERMINATION.** This Agreement may be terminated as provided herein.

7.1 TERMINATION BY CITY. It is mutually understood and agreed by the Contractor and the City that the City may terminate this Agreement, in whole or in part for the convenience of the City, upon thirty (30) consecutive calendar days written notice. It is also understood and agreed that upon such notice of termination, the Contractor shall cease the performance of services under this Agreement. Upon such termination, the Contractor shall provide one final invoice for all services completed and incurred prior to the City's notice of termination. The City shall compensate Contractor in accordance with this Agreement; however, the City may withhold any payment to the Contractor that is held to be in dispute for the purpose of setoff until such time as the exact amount due the Contractor from the City is determined. Nothing contained herein or

elsewhere in this Agreement shall require the City to pay for any services that are not in compliance with the terms of this Agreement and its attachments.

7.2 TERMINATION BY EITHER PARTY. It is further understood and agreed by the Contractor and the City that either party may terminate this Agreement in whole or in part. Such a termination may be made for failure of one party to substantially fulfill its contractual obligations, pursuant to this Agreement, and through no fault of the other party. No such termination shall be made, unless the other party being terminated is granted: a) written notice of intent to terminate enumerating the failures for which the termination is being sought; b) a minimum of ten (10) consecutive calendar days to cure such failures; and c) an opportunity for consultation with the terminating party prior to such termination. However, the City retains the right to immediately terminate this Agreement for default if the Contractor violates any local, state, or federal laws, rules or regulations that relate to the performance of this Agreement. This agreement shall automatically terminate in the event that Contractor ceases to be a competent veterinary physician with a reputable professional standing who is legally qualified to practice veterinary medicine in Texas. In the event of termination by the City pursuant to this subsection, the City may withhold payments to the Contractor for the purpose of setoff until such time as the exact amount due the Contractor from the City is determined.

7.3 TERMINATION SHALL NOT BE CONSTRUED AS RELEASE. Termination by either party shall not be construed as a release of any claims that the terminating party may be lawfully entitled to assert against the terminated party.

Further, the terminated party shall not be relieved of any liability for damages sustained by the terminating party by virtue of any breach of this Agreement.

8. **GENERAL PROVISIONS.**

8.1 NOTICES. All notices, communications and reports under this Agreement shall be either hand-delivered or mailed, postage pre-paid in the United States Postal Service, to the respective parties at the respective addresses shown below, unless and until either party is otherwise notified in writing:

8.2. LAW GOVERNING CONTRACT. For the purpose of determining the place of contract and the law governing same, this Agreement is entered into in the City and County of El Paso, State of Texas, and shall be governed by the laws of the State of Texas. Venue shall be in El Paso County, Texas.

8.3 SUCCESSORS AND ASSIGNS. This Agreement shall be binding on the City and the Contractor, their successors and assigns. Neither party may assign, sublet, or transfer its interest in this Agreement without the written consent of the other.

8.4 VENUE. For the purpose of determining place of Agreement and the law governing the same, this Agreement is entered into in the City and County of El Paso, the State of Texas, and shall be governed by the laws of the State of Texas. Venue shall be in the County of El Paso, Texas.

- 8.5 COMPLIANCE WITH LAWS. Contractor shall comply with applicable Federal, State and local laws and ordinances applicable to the work contemplated herein.
- 8.6 CAPTIONS. The captions of this Agreement are for information purposes only, and shall in no way affect the substantive terms or conditions of this Agreement.
- 8.7 SEVERABILITY. Should any section, paragraph or other provision of this Agreement be found invalid, such invalidity shall not affect the remaining provisions of this Agreement.
- 8.8 CONFLICTING PROVISIONS. Any provision contained in any Attachments to this Agreement, which may be in conflict or inconsistent with any of the provisions in this Agreement shall be void to the extent of such conflict or inconsistency.
- 8.9 ENTIRE AGREEMENT. This Agreement, including attachments, constitutes and expresses the entire agreement between the parties and supersedes all prior negotiations, representations or agreements, whether written or oral. This Agreement shall not be amended or modified, except by written amendment, executed by both parties.



## ATTACHMENT "A"

### Veterinarian

### Scope of Duties – Basic Services

#### **General Purpose:**

Under general direction, supervise and provide contracted veterinary services for the Animal Services Division of Environmental Services.

#### **Typical Duties:**

- Evaluate impounded animals, and provide treatment as necessary.
- Provide surgical services in the spay/Neuter Mobile Van or at the Animal Shelter.
- Administer appropriate vaccines as required.
- Provide surgeries which include spays and castrations and the administration or the supervision of the administration of anesthesia.
- Make determinations regarding animal cruelty or neglect cases.
- Provide or directly supervise the vaccination of surgical animals with rabies vaccine, and implantation of microchip as necessary.
- Remain on site at surgical location to ascertain the patient is out of danger during the post surgical period.
- Monitor animals being held under rabies quarantine.

#### **Minimum Qualifications:**

Education and Experience: A Doctor of veterinary medicine degree and two (2) years of professional veterinary experience in animal medicine, or exotic animal medicine and surgery or completion of residency in zoological medicine.

Licenses and Certificates: Licensed to practice veterinary medicine in the State of Texas by the State Board of Veterinary Medical Examiners.

Texas and Federal Controlled Substance Registration, USDA Accreditation by time of appointment.

Texas Class "C" Driver's License or equivalent from another states.
