SUBJECT: ORDINANCE

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.060 (SCHEDULE VI-PARKING TIME LIMITED ON CERTAIN STREETS), OF THE EL PASO CITY CODE TO AMEND PARAGRAPH "A" TO IDENTIFY THE PARKING TIME LIMIT TO TWO HOURS BETWEEN 8:00 A.M. AND 6:00 P.M., EXCEPT SUNDAYS AND LEGAL HOLIDAYS), ON LAFAYETTE AVENUE FROM ALAMEDA AVENUE TO A POINT 213 FEET NORTHEAST; ON THE WESTSIDE ONLY. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

Engineering Department, Traffic Division received a written request from a property owner to have the prohibited parking area on Lafayette adjacent to his property changed to a 2 hour parking in order to accommodate tenants and customers. Traffic Division has investigated the site and determined that allowing parking next to the building will not interfere with the lanes of traffic. Therefore, we are requesting changes to the ordinance to reflect the change in the parking restriction.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.060 (SCHEDULE VI-PARKING TIME LIMITED ON CERTAIN STREETS), OF THE EL PASO CITY CODE TO AMEND PARAGRAPH "A" TO IDENTIFY THE PARKING TIME LIMIT TO TWO HOURS BETWEEN 8:00 A.M. AND 6:00 P.M., EXCEPT SUNDAYS AND LEGAL HOLIDAYS), ON LAFAYETTE AVENUE FROM ALAMEDA AVENUE TO A POINT 213 FEET NORTHEAST; ON THE WESTSIDE ONLY. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.060 (Schedule VI - Parking time limited on certain streets), Paragraph A (Parking time limit two hours between 8:00 a.m. and 6:00 p.m., except Sundays and legal holidays), of the El Paso City Code shall be and hereby is amended to add the following:

- Lafayette Avenue from Alameda Avenue to a point 213 feet northeast; westside only.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.060 (Schedule VI - Parking time limited on certain streets), Paragraph A (Parking time limit two hours between 8:00 a.m. and 6:00 p.m., except Sundays and legal holidays) of the El Paso City Code, shall remain in full force and effect.
