**SUBJECT: ORDINANCE**

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV, SPEED LIMITS), SUBSECTION "F" (THIRTY-FIVE MILES PER HOUR) OF THE EL PASO CITY CODE, TO DELETE SUBSECTION IDENTIFYING THE SPEED LIMIT AS THIRTY-FIVE MILES PER HOUR ON MISSOURI AVENUE FROM CAMPBELL STREET TO PIEDRAS STREET. THE PENALTY IS AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

**BACKGROUND / DISCUSSION:**

This ordinance was initiated by staff as a result of researching existing speed limits. This segment of Missouri Avenue is considered a frontage road for Interstate Highway 10(I-10) and is under the jurisdiction of the Texas Department of Transportation. The correct speed limit is listed in the section of the city code that pertains to I-10 and frontage roads; therefore, we are asking that the conflicting separate entry in the 35 MPH subsection be deleted.



**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits), Subsection "F" (Thirty-five miles per hour) of the El Paso City Code shall be and hereby is amended to delete subparagraph as follows:

**F. Thirty-five miles per hour:**

**7. Missouri Avenue from Campbell Street to Piedras Street.**

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits) of the El Paso City Code shall remain in full force and effect.
