AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV, SPEED LIMITS), SUBSECTION "F" (THIRTY-FIVE MILES PER HOUR) OF THE EL PASO CITY CODE, TO DELETE THE SPEED LIMIT AS THIRTY-FIVE MILES PER HOUR ON LEE TREVINO FROM GATEWAY EAST BOULEVARD TO BURNHAM DRIVE. THE PENALTY IS AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE

BACKGROUND / DISCUSSION:

There are currently two 35MPH speed limit entries for Lee Trevino, one from Rojas to Gateway West Boulevard and another from Gateway East Boulevard to Burnham Drive. This ordinance eliminates the two references and in their place creates one reference to cover both segments of Lee Trevino. This is simply an administrative change to improve our bookkeeping.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV, SPEED LIMITS), SUBSECTION "F" (THIRTY-FIVE MILES PER HOUR) OF THE EL PASO CITY CODE, TO DELETE THE SPEED LIMIT AS THIRTY-FIVE MILES PER HOUR ON LEE TREVINO FROM GATEWAY EAST BOULEVARD TO BURNHAM DRIVE. THE PENALTY IS AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits), Subsection "F" (Thirty-five miles per hour) of the El Paso City Code shall be and hereby is amended to delete subparagraph as follows:

F. Thirty-five miles per hour:

54. Lee Trevino from Gateway East Boulevard to Burnham Drive.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits) of the El Paso City Code shall remain in full force and effect.


