AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV, SPEED LIMITS), SUBSECTION "G", (FORTY MILES PER HOUR) OF THE EL PASO CITY CODE, TO AMEND SUBSECTION "G" TO IDENTIFY THE SPEED LIMIT ON YARBROUGH DRIVE, FROM BORDER HIGHWAY (LOOP 375) TO SAN PAULO AVENUE. THE PENALTY IS AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BACKGROUND / DISCUSSION:

This ordinance was initiated by staff to amend the existing ordinance and add two words that were omitted in the original ordinance request. The current entry, "Border Highway (Loop 375) to San Paulo Avenue, "omitted" "Yarbrough and "from" out of the original text. The corrected version should read "Yarbrough Drive, from Border Highway (Loop 375) to San Paulo Avenue."

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.150 (SCHEDULE XIV, SPEED LIMITS), SUBSECTION "G", (FORTY MILES PER HOUR) OF THE EL PASO CITY CODE, TO AMEND SUBSECTION "G" TO IDENTIFY THE SPEED LIMIT ON YARBROUGH DRIVE, FROM BORDER HIGHWAY (LOOP 375) TO SAN PAULO AVENUE. THE PENALTY IS AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits), Subsection "G" (Forty miles per hour) of the El Paso City Code shall be and hereby is amended to read as follows:

G. Forty miles per hour:

6. Yarbrough Drive, from Border Highway (Loop 375) to San Paulo Avenue.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.150 (Schedule XIV, Speed Limits) of the El Paso City Code shall remain in full force and effect.
