**AMENDMENT TO THE AGREEMENT
FOR PROFESSIONAL SERVICES**

This Amendment to that certain Agreement for Professional Services is made this _____ day of _____, 2007, by and between the City of El Paso, a Texas municipal corporation (the "**Owner**"), and AIA Consultants, LTD. (the "**Consultant**").

WHEREAS, on November 2, 2006, the Owner and the Consultant entered into an agreement for professional services for a project known as "ON-CALL DRAINAGE SERVICES" (the "**Agreement**");

WHEREAS, the Owner and the Consultant desire to amend the Agreement to increase the payment amount, pursuant to Section 3.2 of the Agreement, because the Owner desires to add additional design services for the Carnegie Street and Drainage Improvement project, as well as any other Storm 2006 projects that might require design services (the "**Services**").

NOW THEREFORE, in consideration of the mutual promises set forth in this Amendment and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. **Scope of Services.** The Owner and the Consultant hereby agree that the Consultant shall perform the Services.
2. **Payments to Consultant.** The second paragraph of Attachment "D" (Payment and Deliverable Schedule) of the Agreement is hereby amended to read in its entirety as follows:

"The maximum amount that will be allowed under this Contract (the Cap) is Four Hundred Thousand Dollars (\$400,000.00). Only the work ordered, approved, and accepted shall be paid by the City."

3. **Time of Completion.**

The Services shall be completed within the original project schedule as set forth in the Agreement, following the Owner's written Notice to Proceed to the Consultant.

4. **Terms and Conditions.**

All terms and conditions of the Agreement and all subsequent Amendments thereto, except as herein revised, shall remain in full force and effect.




