SUBJECT:

Discussion and action on an appeal by property owners of the Manhattan Heights Historic District regarding a decision rendered by the Historic Landmark Commission (HLC) in HLC Case: HPC09-00005; 3200 Wheeling, El Paso, Texas, on February 2, 2009, to approve a Certificate of Appropriateness for the referenced property.

BACKGROUND / DISCUSSION:

The Historic Landmark Commission at its regularly scheduled meeting on February 2, 2009, reviewed a Certificate of Appropriateness application submitted by the El Paso Independent School District. EPISD proposes to construct a multi-use building on the Crockett Elementary School campus, which is located within the Manhattan Heights Historic District. The staff recommendation was to approve the design with modifications. By a unanimous vote of 6-0, the Historic Landmark Commission approved the Certificate of Appropriateness with the following modifications: 1) relocate the building to the northwest corner of campus; 2) provide a landscape buffer; 3) brick the exterior facades to match the historic elementary school; and 4) relocate the roof access ladder.




2 SITE PLAN
