This ordinance is to amend the proceeding ordinance to exclude 12215 Pine Springs from the no stopping or standing, tow-away zone along Pine Springs. AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING - TOW-AWAY ZONE), SUBSECTION (A) OF THE EL PASO CITY CODE, BY DELETING A PORTION OF PINE SPRINGS DRIVE. THE PENALTY BEING AS PROVIDED IN SECTION 12.88.180 OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing - Tow-Away Zone), subsection (A) of the El Paso City Code shall be and hereby is amended to read as follows:

Pine Springs Drive from Loma Verde Drive west to a point 120 feet east of its terminus.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing - Tow-Away Zone), subsection (A) of the El Paso City Code shall remain in full force and effect.
