**SUBJECT:**

Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited At All Times On Certain Streets), of the El Paso City Code, to add Weston Brent Lane, the penalty being as provided in Section 12.84.010 and Chapter 12.85 of the El Paso City Code.

**BACKGROUND/DISCUSSION:**

City representative hosted a meeting with Business owners along Weston Brent to discuss speeding and driveway visibility issues. The businesses want parking to be restricted due to their concern for accidents due to parked vehicles obstructing their sight-distance at the driveways. Additionally, the business owners stated that pedestrians were at danger due to the parked vehicles and speeding along the street. Department of Transportation conducted a 96-hour speed study (Thursday – Sunday) and the 85% speed was 25 MPH with 3.2% of all vehicles recorded exceeding 30 MPH.

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS), OF THE EL PASO CITY CODE, TO ADD WESTON BRENT LANE, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at times on certain streets), of the El Paso City Code, is amended to add the following paragraph:

Weston Brent Lane

**Section 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.


