Introduction of ordinance to amend TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.08, SECTION 12.08.230 (DISABLED-PARKING ENFORCEMENT VOLUNTEERS) OF THE EL PASO CITY CODE TO AMEND THE PROVISIONS RELATING TO APPROVAL OF VOLUNTEER SERVICES AGREEMENT BY CITY MANAGER

Section 12.08.230 of the City Code requires that the disabled-parking enforcement volunteers sign a volunteer services agreement that is approved by the City Council and the Civil Service Commission before their appointment becomes effective. The amendment will allow this to be administratively approved by the City Manager.

AN ORDINANCE AMENDING TITLE 12
(VEHICLES AND TRAFFIC), CHAPTER 12.08, SECTION 12.08.230 (DISABLED-
PARKING ENFORCEMENT VOLUNTEERS) OF THE
EL PASO CITY CODE TO AMEND THE PROVISIONS RELATING TO APPROVAL
OF VOLUNTEER SERVICES AGREEMENT BY CITY MANAGER

WHEREAS, El Paso City Council finds that an ordinance amendment is in the best interest of the City of El Paso and its citizens and is designed to promote efficiency and the public safety and welfare of its citizens.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Section 12.08.230 D. (Disabled-parking enforcement volunteers-- Parking citation issuance authority.) be amended to read as follows:

12.08.230 D. Appointment of a disabled-parking enforcement volunteer shall become effective upon the execution of the volunteer services agreement by the City Manager or designee and the volunteer and completion of the volunteer's training.

Section 2. Except as herein amended, Chapter 12.08 (Vehicles and Traffic) of the El Paso City Code, shall remain in full force and effect.


