

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.200 (SCHEDULE XVII – RESTRICTIONS ON PARKING IN RESIDENTIAL DISTRICTS), OF THE EL PASO CITY CODE, TO ADD PRINCE EDWARD AVENUE, RUSHING ROAD, DONALD DRIVE AND MCCOMBS STREET, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.200 (Schedule XVII – Restrictions on parking in residential districts), of the El Paso City Code, is amended to add a new paragraph to read as follows:

Zone T: No parking, 7:00 a.m. to 4:00 p.m., School Days Only
Beginning at the intersection of Prince Edward Avenue and Rushing Road;
Thence, north along the centerline of Rushing Road to its intersection of Donald Drive;
Thence, east along the centerline of Donald Road to its intersection of McCombs Street;
Thence, south along the centerline of McCombs Street to its intersection of Prince Edward Avenue;
Thence, west along Prince Edward to the point of beginning.

Section 2. Except as herein amended, Title 12, of the El Paso City Code shall remain in full force and effect.




