AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS) TO DELETE VARIOUS EXISTING LOCATIONS AS THE PROPOSED DELETIONS ARE DUPLICATES FOUND ELSEWHERE IN SECTION 12.88.030. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO MUNICIPAL CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets.) of the El Paso Municipal Code shall be and hereby is amended to delete existing subparagraphs as follows:

- 373. Both sides of San Antonio Avenue from Campbell Street to Kansas Street;
- 374. Both sides of Myrtle Avenue from Campbell Street to Kansas Street;
- 375. Both sides of Campbell Streets from San Antonio Avenue to Myrtle Avenue;
- 376. Both sides of Kansas Street from San Antonio Avenue to Myrtle Avenue;
- 377. Both sides of Overland Avenue from Florence Street to Ochoa Street;
- 378. Both sides of Florence Street from San Antonio to Overland Avenue;
- 379. West side of Ochoa Street from San Antonio Avenue to Overland Avenue;
- 380. South side of San Antonio Avenue from Florence Street to Ochoa Street;

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets.) of the El Paso City Code, shall remain in full force and effect.


