AN ORDINANCE AMENDING ORDINANCE NO. 017298 RELATING TO THE COLLECTION OF COMMERCIAL SOLID WASTE IN REQUIRED COMMERCIAL COLLECTION AREAS, TO CHANGE THE EFFECTIVE DATE

WHEREAS, on March 23, 2010, the City Council of the City of El Paso approved Ordinance No. 017298, which required that all the commercial waste generators within areas of the City designated as Required Commercial Collection Areas, receive comprehensive waste collection services from the City;

WHEREAS, Ordinance No. 017298 was to become effective June 1, 2010 and staff now wishes to replace said effective date for a date further in the future.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Ordinance No. 017298 be amended to change the effective date indicated in Section 11 of that ordinance from June 1, 2010 to September 1, 2010.

Section 2. That except as amended herein, Ordinance No. 017298 shall remain in full force and effect.
