**SUBJECT:**

An ordinance repealing Ordinance number 017042 (Transportation Reinvestment Zone Number one for El Paso, Texas ): Declaring Ordinance number 017042 void.

**BACKGROUND / DISCUSSION:**

Transportation Reinvestment Zones (TRZ's) were one of the proposed funding mechanisms the City of El Paso agreed to create as part of the 2008 Comprehensive Mobility Plan (CMP). TRZ #1 was created by City Council on December 23, 2008, however, it included parcels in Fort Bliss and therefore broke the contiguity of the zone as required by state law. This action finds TRZ #1 void and repeals the ordinance that created the Zone. Replacement zones that will be utilized to generate the revenue stream to meet the City's obligations to the 2008 Comprehensive Mobility Plan and to the Camino Real Regional Mobility Authority (CRRMA) are being considered by Council separately from this action.

**PRIOR COUNCIL ACTION:**

July 2008 – Approval of 2008 CMP  
April 6, 2010 – Approved Notice of Intent to Create TRZ  
April 20, 2010 – Public Hearing on the creation of TRZ #2 and #3.

**AMOUNT AND SOURCE OF FUNDING:**

No funding is required to create the zones.



AN ORDINANCE REPEALING ORDINANCE NUMBER 017042 (TRANSPORTATION REINVESTMENT ZONE NUMBER ONE FOR EL PASO, TEXAS); DECLARING ORDINANCE NUMBER 017042 VOID.

**WHEREAS**, Ordinance 017042 was adopted by the City Council on December 23, 2008 creating Transportation Reinvestment Zone Number One; and

**WHEREAS**, Ordinance 017042 required, pursuant to Section 222.106 of the Texas Transportation Code, that the area within Transportation Reinvestment Zone One be a contiguous geographical area located within the jurisdiction of the municipality; and

**WHEREAS**, the geographical area described in Ordinance 017042 included non-contiguous areas.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

That Ordinance 017042 is found to be void from its inception for its inclusion of non-contiguous geographical areas within Transportation Reinvestment Zone Number One, and that Ordinance 017042 is hereby repealed.


