El Paso Sun City Pride is seeking permission to sell and serve alcoholic beverages within the closed portions of City right-of-way during El Paso Sun City Pride has authorized Epic Nightclub and Bar to sell and serve the alcoholic beverages on their behalf during the event. The El Paso Sun City Pridefest from 12:00 pm Saturday, June 8, 2013 to 1:00 am Sunday, June 9, 2013.

A special privilege permit (NESV13-00015) was approved by the Downtown Management District (DMD) AdHoc committee for the temporary street closure.

**WHEREAS**, El Paso Sun City Pride (hereinafter referred to as “Grantee”) is sponsoring The El Paso Sun City Pridefest from 7:00 pm Friday, June 7, 2013 through 5:00 am Sunday, June 9, 2013 (hereinafter referred to as “Event”); and

**WHEREAS**, the City is not a sponsor of the Event and the Grantee assumes full responsibility for the planning, coordination, management and production of the Event; and

**WHEREAS**, the Grantee has authorized Epic Nightclub and Bar (hereinafter referred as “Licensee”) to provide for the sale and service of alcoholic beverages during the Event; and

**WHEREAS**, the Grantee has received administrative approval for a Special Privilege Permit for the use and closure of City rights-of-way for more than twenty-four (24) hours on portions of City rights-of-way on Franklin Avenue between Santa Fe Street and Oregon Street and on El Paso Street between Main Drive and Franklin Avenue, from 7:00 pm Friday, June 7, 2013 to 5:00 am Sunday, June 9, 2013, in conjunction with the proposed Event; and

**WHEREAS**, both the Grantee and Licensee desire to provide for the sale and service of alcoholic beverages on the closed portions of City rights-of-way during the Event; and

**WHEREAS**, the Texas Alcoholic Beverage Commission requires that the City Council for the City of El Paso approve, as a permissible activity, the sale and service of alcoholic beverages during the City Event.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

That the sale and service of alcoholic beverages by El Paso Sun City Pride and Epic Nightclub and Bar in the closed portions of City rights-of-way on Franklin Avenue between Santa Fe Street and Oregon Street and on El Paso Street between Main Drive and Franklin Avenue, from 12:00 pm Saturday, June 8, 2013 to 1:00 am Sunday, June 9, 2013 is a permissible activity in conjunction with The El Paso Sun City Pridefest.
