**SUBJECT:**

Approve an Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking Prohibited At All Times On Certain Streets), of the El Paso City Code, to delete Grama Street and San Antonio Avenue, the penalty being as provided in Section 12.84.010 and Chapter 12.85 of the El Paso City Code.

**BACKGROUND/DISCUSSION:**

There are currently a few signs prohibiting on-street parking next to the new apartment complex at 3501 San Antonio by Grama. This amendment is at the request of the property owner to allow public parking adjacent to their facility. The neighboring resident by this intersection was also contacted regarding this proposal and he has no objections. At this time, the Department of Transportation recommends the location be removed from the schedule.



**AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS), OF THE EL PASO CITY CODE, TO DELETE GRAMA STREET AND SAN ANTONIO AVENUE, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 AND CHAPTER 12.85 OF THE EL PASO CITY CODE.**

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:**

**Section 1.** That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III – Parking prohibited at times on certain streets), of the El Paso City Code, is amended to delete the following paragraphs:

- 338. Grama Street, both sides, from San Antonio Avenue to a point 167 feet north
- 340. San Antonio Avenue, north side only, from Grama Street to a point 210 feet east

**Section 2.** Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.



ORDINANCE NO. 15913

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III - PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS.) TO ADD NEW LOCATIONS ON GRAMA STREET, BOTH SIDES, FROM SAN ANTONIO AVENUE TO A POINT 167 FEET NORTH; ON GRAMA STREET, BOTH SIDES, FROM SAN ANTONIO AVENUE TO A POINT 60 FEET SOUTH; ON SAN ANTONIO AVENUE, NORTH SIDE ONLY, FROM GRAMA STREET TO A POINT 210 FEET EAST; ON SAN ANTONIO AVENUE, SOUTH SIDE ONLY, FROM GRAMA STREET TO A POINT 510 FEET EAST; AND ON SAN ANTONIO AVENUE, SOUTH SIDE ONLY, FROM GRAMA STREET TO A POINT 73 FEET WEST. THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 OF THE EL PASO MUNICIPAL CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:


1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets.) of the El Paso Municipal Code shall be and hereby is amended to add new subparagraphs as follows:

- Grama Street, both sides, from San Antonio Avenue to a point 167 feet north.
- Grama Street, both sides, from San Antonio Avenue to a point 60 feet south
- San Antonio Avenue, north side only, from Grama Street to a point 210 feet east.
- San Antonio Avenue, south side only, from Grama Street to a point 510 feet east.
- San Antonio Avenue, south side only, from Grama Street to a point 73 feet west.

2. Except as expressly herein amended, all other provisions of Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.030 (Schedule III - Parking prohibited at all times on certain streets.) of the El Paso City Code, shall remain in full force and effect.




