Recommend City Council award Bid 2008-101, Sexual Assault Services, to Tenet Hospitals LTD D/B/A Sierra Medical Center for three years for an amount not to exceed \$109,500 annually.

**BACKGROUND / DISCUSSION:**

The El Paso Police Department is seeking a qualified company to perform medical examinations on all sexual assault victims and suspects. Services to be performed include, but are not limited to, taking vital signs, history of the assault, past medical history, recording injuries, body diagrams, genital examination, diagnostic tests, treatment for pregnancy and prophylaxis and collection of evidence. All results of medical examinations shall be available to the investigating unit no later than 72 hours after the examination and all examination results will be kept strictly confidential and secure.

Tenet Hospitals LTD D/B/A Sierra Medical Center was the bid's single responder and is evaluated as responsive. Tenet Hospitals LTD is presently providing these services to EPPD responsibly and responsively.

**PRIOR COUNCIL ACTION:**

The previous Sexual Assault Services contract was awarded by City Council in 2005 under Bid 2005-094R.

This purchase will be funded under Dept ID 21010072 Acct 502111 Class 21000 Fund 01101.



Tenent Hospitals Ltd. dba Sierra Medical Center was the sole bidder for this procurement. Six (6) vendors were contacted to determine why they did not submit a bid for this solicitation.

1. Thomason Hospital - Blas Meza, Patient Care Services - Emergency Department, received a copy of the bid and he and several departments reviewed a number of strategies to respond to this bid but declined to bid at this time for the following reasons: 1) the Emergency Department's daily capacity is currently maximized; 2) the Hospital cannot address the privacy issues specified for the waiting and admission areas; and 3) the Hospital cannot meet the three (3) hour deadline to initiate and complete the medical examination activities as required by the bid.

2. Las Palmas and Del Sol Regional Healthcare Systems (5 locations) - Chris Estrada polled physicians and determined that they were not comfortable in providing this type of service with the possibility of having to go to court and declined to bid.

3. Westside Urgent Care Center - Ruby Acosta said that they do not have the facilities (privacy room) and other specifics required to submit a response.

4. Concentra Medical Centers - Patricia Gabbard just took over the position from Rene Flores who was promoted. She is reviewing the scope of services to see if they would have been able to submit a bid.

5. Texas Tech Medical Center - Ms. Himenia said they would not be able to provide this type of service since they are a Science Center (Psychiatric).

6. Mesa Medical Clinic - This Clinic is no longer in service.
