**AN ORDINANCE REPEALING ORDINANCE NUMBER 013472,
WHICH AUTHORIZED THE TWELVE TRAVELERS REVIEW COMMITTEE
AND PROVIDED FOR THE APPOINTMENT OF AND DEFINED
THE DUTIES OF MEMBERS OF THE COMMITTEE.**

WHEREAS, on November 24, 1992, the City Council of the City of El Paso (the "Council") approved a Commission Agreement ("Agreement") with John Houser (the "Artist") to construct a project known as the Twelve Travelers Memorial (the "Project");

WHEREAS, Article V, Section 5.04, of the Agreement established the XII Travelers Review Committee for the purpose of making recommendations to Council concerning the subjects to be depicted in the Project; reviewing designs, models and drawings submitted to the City for approval and make recommendations concerning approval or disapproval; and making a recommendation to Council concerning whether or not to exercise the option to complete the Project;

WHEREAS, on January 20, 1997, the Council adopted Ordinance No. 013472 which provided for the continued authorization of the Twelve Travelers Review Committee ("Committee") established by the Agreement and provided for the appointment of members of the Committee as well as defined the duties of such members;

WHEREAS, on April 4, 2006, the Council adopted Ordinance No. 16324 which provided for art in municipal places and established the El Paso Public Art Committee to review all public art projects to include projects gifted to the City; and

WHEREAS, it has been determined that the El Paso Public Art Committee will administer the public art program for the City and that the Twelve Travelers Review Committee is no longer necessary.


