AMENDMENT NO. 1
TO
THE AGREEMENT BETWEEN
THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT HOUSTON
AND
CITY OF EL PASO

This Amendment entered into and effective on this _____ day of March, 2013, modifies the Agreement between The University of Texas Health Science Center at Houston ("University") and City of El Paso ("Contractor") dated May 22, 2012 (the "Agreement"), as follows:

1. Section 2. The entire section shall be replaced as follows: "Duration of Agreement: This Agreement shall be effective May 22, 2012, and shall terminate on February 28th, 2014. Either party may terminate this Agreement with or without cause upon thirty (30) days written notice to the other party."
2. Section 3. The entire section shall be replaced as follows: "Compensation: University shall compensate Contractor as tasks are completed as shall be measured by the number of surveys conducted, caller navigation records, and staff training.

For the duration of the first project year, through February 28, 2013, Contractor shall be compensated at \$71,855.44. For year two, Contractor shall be paid \$78,366.

The total value of this agreement shall not exceed \$150,221."

3. Except as herein amended, the Agreement shall remain in full force and effect.
4. In witness whereof, the parties hereto have executed this Amendment under their respective hands as of the day and year first mentioned above in duplicate copies, each of which shall be deemed an original.
