**Larry M. Medina**

Larry M. Medina was born and raised in El Paso, Texas and is a United States Air Force Veteran. He attended both EPCC where he served as President of its Student Government and a member of Phi Theta Kappa and the University of Texas at El Paso-UTEP where his double major is in Economics and Finance.

Larry Medina is founder and President of Pan American Insurance & Investments with 14 branches throughout the county, President of Texas Safer Drivers Driving Schools, Inc., and Firm Administrator of the Reyes & Blumenfeld, PLLC Law Firm.

Over the past 27 years he has been active in civic organizations that include the El Paso Library Board Association, Jaycees, Viva El Paso Board, Rotary Club, Central District Civic Association, Downtown Development Association, Five Points Development Association, Boys & Girl Clubs, Knights of Columbus, past National Secretary for LULAC, and Founding Member of the El Paso/Juarez World Trade Center.

Larry Medina served as Commissioner to the Housing Authority of the City of El Paso (HACEP) appointed by Mayor John Cook first in June 2005 and then again in May 2007.

Larry Medina also served as City Council Representative six years (1997-2003) in El Paso's City Council. In 2001 his City Council colleagues elected him unanimously as Mayor Pro Tem until his end of his term in June 2003.

Larry Medina was El Paso County Commissioner on January 4<sup>th</sup>, 2006 appointed by El Paso County Judge Dolores Briones and served until November 20<sup>th</sup>, 2006.

As Mayor Pro Tem, Larry Medina served as Vice-Chair of the Mass Transit Board and in the Central Appraisal District Board. He served as Chairman of Economic Development, Chairman of the History Museum, Chairman of Public Works and Streets Legislative Review Committees and was a member of the Architectural Engineering Selection Committee, Community Development, Convention and Visitor's Bureau, Engineering, Parks and Recreation, Police, Tourism and Zoo Legislative Review Committees.

As the City of El Paso's Mayor Pro Tem, Larry Medina "championed" the nation's toughest and healthiest Clean In-door Air Public Ordinance, and as a result of his hard work the Board of Directors of the American Cancer Society presented him with the "True Grit" award. This award is given to one elected official annually to honor him/her for taking extraordinary personal risks to impact public policy in support of cancer prevention, detection, or treatment.

Because of Commissioner Larry Medina's strong conviction that as an elected official it was his duty to protect innocent children, employees, and customers from the hazards of second-hand smoke, he has been invited to speak on this issue at many conferences in dozens of cities across the United States and abroad.
