AN ORDINANCE AMENDING THE NON-EXCLUSIVE BUS BENCH FRANCHISE PREVIOUSLY GRANTED TO BENCH ADS OF EL PASO, INC. BY ORDINANCE NUMBER 016793, TO REFLECT EL PASO BENCH ADS, LLC AS THE NEW FRANCHISEE; THE PENALTIES BEING AS PROVIDED IN SECTION 13.20.110 OF THE EL PASO CITY CODE.

WHEREAS, the City of El Paso had previously granted a non-exclusive bus bench franchise to Bench Ads of El Paso, Inc. through ordinance number 016793;

WHEREAS, Bench Ads of El Paso, Inc. now desires to assign its non-exclusive bus bench franchise to El Paso Bench Ads, LLC; and

WHEREAS, the City of El Paso has determined that a continued need exists for the installation and maintenance of bus benches and shelters on public rights of way adjacent to established Sun Metro bus stops wherever possible for the convenience and benefit of members of the public utilizing the public transportation system provided by the City of El Paso;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO THAT:

- I. The City of El Paso (hereinafter referred to as the "City") hereby amends the non-exclusive bus bench franchise granted by Ordinance number 016793 to Bench Ads of El Paso, Inc., as follows:
 - A. The Grantee originally identified within Ordinance No. 016793 shall be and hereby is amended from Bench Ads of El Paso, Inc. to El Paso Bench Ads, LLC; provided, however, that such amendment is subject to and conditioned upon El Paso Bench Ads, LLC compliance with the terms and conditions of a bus bench franchise, including but not limited to the requirements of Ordinance No. 016793, the Bus Bench Franchise Rules and all applicable El Paso City Code provisions.
 - B. Any notices provided pursuant to the amended franchise shall be provided by certified mail, return receipt requested, directed to the following addresses, as may be amended from time to time in writing by either party:

Bench Ads of El Paso, Inc. and El Paso Bench Ads, LLC shall indicate acceptance and acknowledgment of the provisions of this ordinance in writing within thirty (30) calendar days after the passage and approval thereof. In the event either party fails to accept and acknowledge as required herein, the authority granted by this instrument shall immediately terminate.
- III. All other remaining terms and conditions of Ordinance No. 016793 shall remain in full force and effect.


