Ordinance amending Title 2 (Administration & Personnel) of the City of El Paso Code to delete Chapter 2.06 (Bond Overview Advisory Committee) in its entirety.

BACKGROUND / DISCUSSION:

After the 2000 QOL Bond election, Council created the Bond Overview Advisory Committee to coordinate, prioritize and provide public information and other functions related to this particular bond issuance. The 2000 QOL program is near completion with only 2 projects remaining under construction. No further coordination or recommendations for prioritization are anticipated. Given the near completion of this program, the Engineering Department is recommending the City Code be amended to eliminate references to this advisory committee.

PRIOR COUNCIL ACTION:

Council created the Bond Overview Advisory Committee on June 13, 2000 to support the execution of the 2000 QOL Bond program.

AN ORDINANCE AMENDING TITLE 2 (ADMINISTRATION AND PERSONNEL) OF THE EL PASO CITY CODE TO DELETE CHAPTER 2.06 (BOND OVERVIEW ADVISORY COMMITTEE) IN ITS ENTIRETY

WHEREAS, on May 6, 2000, the voters of the City of El Paso, Texas, authorized the issuance of general obligation bonds for the purposes of library facilities; park and recreation facilities; zoo facilities; and a history museum complex together with the improvements therefore; and,

WHEREAS, as June 13, 2000, the City Council of El Paso established a Bond Overview Advisory Committee for the purpose of gathering information and making recommendations to the Mayor for the coordination, prioritization, public information and other functions related to the bonds and funded projects; and,

WHEREAS, the Mayor and City Council find that there is no longer a need for a Bond Overview Advisory Committee because the 2000 Quality of Life program of work has been substantially completed and the coordination, prioritization and public information regarding these projects is minimal,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO, TEXAS:

1. That Title 2 (Administration and Personnel) of the El Paso City Code is amended by deleting Chapter 2.06, (Bond Overview Advisory Committee), in its entirety.
2. Except as expressly amended herein, all other provisions of Title 2 (Administration and Personnel) of the El Paso City Code shall remain in full force and effect.
