**SUBJECT:**

To approve Enterprise Leasing Co. and Acme Auto Leasing LLC as the selected vendors to provide unmarked rental vehicle services to the El Paso Police Departments. The selection of these vendors was based on bids submitted to the Purchasing Department and taking into consideration the needs of the El Paso Police Department. This is a low bid selection. Total estimated annual costs of leasing per company will be \$420,284.00 for Enterprise Leasing Co. and \$67,800.00 for Acme Auto Leasing LLC.

**BACKGROUND / DISCUSSION:**

The El Paso Police Department is requesting the service of unmarked rental vehicles to be provided by Enterprise Leasing Co. and Acme Auto Leasing to be utilized for undercover operations. These expenses will be covered by federal and state grant funds.



On April 22, 2009 bids were opened for the subject project. Capps Rent-A-Car Inc, 8555 John Carpenter Freeway, Dallas, TX 75247 took several exceptions to the subject bid including:

- Intermediate (midsize) sedans -4 door offered by the vendor are 4 cylinder engines not 6 cylinder as required in the bid. ^
- Vehicles in the bidder's solicitation are two to three year old models not up to one model year old as required in the bid.^
- Vehicles in the bidder's solicitation can not be returned by El Paso PD after reaching 25,000 miles. The subject solicitation requires successful bidder to take back vehicles after they have reached 25,000. ^

Capps Rent-A-Car Inc. is therefore a non-responsive bidder for solicitation No. 2009-192, Lease of Unmarked Police Vehicles.
