BACKGROUND/DISCUSSION

Solicitation 2007-010 Pierce Proprietary Parts was awarded to First In, Inc. on October 24, 2006 for three years and then extended on August 11, 2009 for two additional years and set to expire on October 24, 2011 with no additional extensions. The sale of "Pierce" parts is done through exclusive protected territory. Pierce Manufacturing has advised that this territory has been reassigned and that acquisition of their parts should occur through this new distributor.


