AN ORDINANCE AMENDING TITLE 12(VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES) SECTION 12.88.180 (NO STOPPING OR STANDING – TOW-AWAY ZONE), SUBSECTION (A) OF THE EL PASO MUNICIPAL CODE, BY AMENDING A LOCATION ON MISSOURI AVENUE. THE PENALTY BEING AS PROVIDED IN SECTION 12.88.180 OF THE EL PASO MUNICIPAL CODE.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING - TOW-AWAY ZONE), SUBSECTION (A) OF THE EL PASO MUNICIPAL CODE, BY AMENDING A LOCATION ON MISSOURI AVENUE. THE PENALTY BEING AS PROVIDED IN SECTION 12.88.180 OF THE EL PASO MUNICIPAL CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing - Tow-Away Zone), subsection (A) of the El Paso Municipal Code shall be and hereby is amended to revise an existing subparagraph as follows:

75. Missouri Avenue between Piedras Street and Brown Street, both sides, and between Brown Street and Ange Street, south side only.

SHALL BE REVISED TO READ AS FOLLOWS:

75. Missouri Avenue from 180 feet east of Rosewood Street to Brown Street, north side; Missouri Avenue between Piedras Street and Brown Street, south side; and Missouri Avenue between Brown Street and Ange Street, south side.

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No Stopping or Standing - Tow-Away Zone), subsection (A) of the El Paso Municipal Code shall remain in full force and effect.




