AN ORDINANCE AMENDING ORDINANCE NO. 17924 AMENDING TITLE 5 (BUSINESS LICENSE AND PERMIT REGULATIONS) OF THE EL PASO CITY CODE TO ADD CHAPTER 5.17 (CREDIT ACCESS BUSINESSES) IN ORDER TO SET FORTH REGISTRATION REQUIREMENTS AND CREDIT EXTENSION GUIDELINES, TO AMEND THE EFFECTIVE DATE OF ORDINANCE NO. 17924.

WHEREAS, on January 8, 2013, the City Council for the City of El Paso passed and approved Ordinance No. 17924 adding Chapter 5.17 (Credit Access Businesses) to Title 5 (Business License and Permit Regulations) of the El Paso City Code to set registration requirements and credit extension guidelines for Credit Access Businesses; and

WHEREAS, the effective date set forth in Ordinance No. 17924 regulating Credit Access Businesses is July 1, 2013; and

WHEREAS, the El Paso City Council desires to amend the effective date of Ordinance No. 17924 from July 1, 2013 to January 16, 2014.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1. That the effective date of Ordinance No. 17924 regulating Credit Access Businesses is January 14, 2014.

SECTION 2. Except as expressly herein amended, Ordinance No. 17924 shall remain unchanged.
