AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041 (SCHEDULE IVA - PARKING PROHIBITED DURING CERTAIN HOURS- SCHOOL DAYS ONLY) OF THE EL PASO CITY CODE BY ADDING THE AREA OF NO PARKING ON MISSY YVETTE DRIVE TO INCLUDE BOTH SIDES FROM PELLICANO DRIVE TO BEN PROCTOR DRIVE; THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

**BACKGROUND / DISCUSSION:**

Residents submitted a petition for restricting parking on Missy Yvette between Pellicano and Ben Proctor. The Traffic Division reviewed the petition and concluded there is enough support from the neighborhood to prohibit parking on this portion of Missy Yvette. The other portion of Missy Yvette currently has parking restrictions signs. The Traffic Engineering Division recommends approval of this ordinance.



AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.041 (SCHEDULE IVA - PARKING PROHIBITED DURING CERTAIN HOURS- SCHOOL DAYS ONLY) OF THE EL PASO CITY CODE BY ADDING THE AREA OF NO PARKING ON MISSY YVETTE DRIVE TO INCLUDE BOTH SIDES FROM PELLICANO DRIVE TO BEN PROCTOR DRIVE; THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010 (VIOLATION--PENALTY) OF THE EL PASO CITY CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041 (Schedule IVA – Parking prohibited during certain hours – school days only) of the El Paso City Code shall be and hereby is amended by changing Number 13 to read as follows:

13. Missy Yvette Drive from Pellicano Drive to Ben Proctor Drive on both sides, and Missy Yvette north of Ben Proctor, east side from addresses 1444 through 12148, and the west side from addresses 1445 through 12153;

2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.041 (Schedule IVA – Parking prohibited during certain hours – school days only) of the El Paso City Code shall remain in full force and effect.


